

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek:

Being part of the Northwest Quarter, of Section 24, of Township 11, Range 13, of the Congress Lands East of the Scioto River, being part of the Frederick S Weaver Jr and Patricia J Weaver property recorded in Deed Book Volume 944, Page 241, of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 08-40-24-32-000, and more particularly described as follows;

Commencing at the unmarked Center of Section 24;

- TIE-1 **THENCE North 86 degrees 28 minutes 05 seconds West 187.29 feet** along the common line for the Southwest and Northwest Quarters of Section 24 to a common corner for said Weaver property and for the Ronald L Welch and Erin E Welsh property recorded in Official Record Volume 1813, Page 700, further being on the West right of way for State Route 555 (Center Road);
- TIE-2 **THENCE North 03 degrees 56 minutes 25 seconds East 200.65 feet** into said Northwest Quarter and along said properties and right of way to a concrete monument (found), passing a concrete monument (found) at 58.48 feet
- TIE-3 **THENCE North 10 degrees 26 minutes 55 seconds West 408.63 feet** continuing along said Weaver and Welsh properties and right of way to an iron pin (set), passing an iron pins (set) at 192.29 feet and 324.49 feet;
- TIE-4 **THENCE North 07 degrees 35 minutes 25 seconds East 221.88 feet** continuing along said Weaver and Welsh properties and West right of way to an iron (set) at the place of beginning for the property herein intended to be described, passing an iron pin (set) at 35.00 feet;
- #1- **THENCE North 79 degrees 01 minutes 25 seconds West 151.82 feet** crossing said Weaver property to an iron pin (set) on the common line for said Weaver property and for the Robert Lee Deitrick property recorded in Official Record Volume 1789, Page 110;
- #2- **THENCE along a curve to the right having, a chord bearing North 11 degrees 29 minutes 40 seconds East 47.64 feet, a radius of 2637.85 feet, and arc length of 47.64 feet,** along said Weaver and Deitrick properties to an iron pin (found);
- #3- **THENCE along a curve to the right having, a chord bearing North 20 degrees 11 minutes 55 seconds East 270.04 feet, a radius of 948.04 feet, and arc length of 270.96 feet,** along said Weaver and Deitrick properties to an iron pin (found);
- #4- **THENCE along a curve to the right having, a chord bearing North 36 degrees 34 minutes 30 seconds East 270.04 feet, a radius of 948.04 feet, and arc length of 270.96 feet,** along said Weaver and Deitrick properties to a concrete monument (found) on the West right of way of said road and corner of said Welsh property;
- #5- **THENCE South 16 degrees 42 minutes 25 seconds West 261.88 feet** along said Weaver and Welsh properties and West right of way to an iron pin (set);
- #6- **THENCE South 07 degrees 35 minutes 25 seconds West 297.67 feet** continuing along said Weaver and Welsh properties and West right of way to the place of beginning, **containing 1.23 acres.**




