Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, Township 11, Range 13, Southwest Quarter of Section 27, and bounded and described as follows:

Beginning at a stone at the Northeast corner of the Southwest Quarter of Section 27; thence South 0° 00' 00" West along East line of quarter section 114.63 feet to an iron pin set on the West line of old Zanesville and Western Railroad, Cannelville branch; thence along the West line of said railroad the following two (2) courses and distances, South 38° 14' 44" West 169.90 feet to an iron pin set, and South 38° 22' 19" West 292.26 feet to an iron pin set; thence leaving said railroad North 61° 23' 27" West 165.06 feet to an iron pin set; thence North 20° 51' 23" East 193.21 feet to an iron pin set; thence North 22° 25' 04" East 235.40 feet to an iron pin set on the North line of the Southwest Quarter of Section 27; thence along the North line of said quarter section North 90° 00' 00" East 272.94 feet to the place of beginning, containing 2.694 acres more or less.

Bearings are based on the East line of the Southwest Quarter of Section 27 bearing South 0° 00' 00" West.

Being all of Parcel Number
Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.


