

- #3- THENCE South 65 degrees 59 minutes 43 seconds East 138.26 feet continuing through said property to an iron pin (set);
- #4- THENCE South 23 degrees 02 minutes 47 seconds East 403.79 feet continuing through said property to an iron pin (set);
- **#5-** THENCE South 52 degrees 59 minutes 50 seconds East 140.28 feet through said property to an iron pin (set);
- #6- THENCE South 33 degrees 04 minutes 56 seconds East 238.23 feet continuing through said property to an unmarked point in the centerline of State Route 555 (Center Road), passing an iron pin (set) at 200.81 feet;
