0.41 Acre Split of Sarchet, to Trade with Moran

Situated in the State of Ohio, County of Muskingum, Township of Cass, and being a part of Lot 2, in Quarter Township 3, Township 3 North, Range 8 West, United States Military Lands, and being part of the lands presently owned by Josephine J. Sarchet(DR 780-167), and being more particularly described as follows:

Beginning for reference at the Northeast Corner of Lot 2, thence along the east line of said Lot 2 and the east line of lands presently owned by J. J. Sarchet(DR 780-167) by deed, South 05 degrees 02 minutes 00 seconds West, 578.00 feet to an iron pipe found on the northeast corner of lands presently owned by Peggy L. Moran(OR 1728-754);

Thence along the north line of said Moran lands, North 84 degrees 44 minutes 41 seconds West, 226.02 feet to an iron pin set and the principal place of beginning;

Thence continuing along Moran's north line, North 84 degrees 44 minutes 41 seconds West, 323.98 feet to a point in the center of Morgan's Lane, a private road, whose right of way at this location is 50 feet, passing an iron pipe found at 279.97 feet;

Thence along the center of said Morgan Lane, North 60 degrees 42 minutes 15 seconds East, 187.00 feet to a point;

Thence leaving said centerline, and through the lands of J. J. Sarchet(DR 780-167), the following two courses:

- 1.) South 69 degrees 45 minutes 07 seconds East, 32.93 feet to an iron pipe found;
- 2.) South 49 degrees 31 minutes 27 seconds, East, 169.12 feet to the principal place of beginning, containing 0.41 acres more or less, subject all legal right of ways and applicable easements, written or implied.

Appended to the above described tract is any grantor's right of ingress and egress from Cass Twp. Rd. 77, Red Bud Road, along Morgan Lane to the above described tract.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.


