**LEGAL DESCRIPTION**  
**Tract 2**

Situated in the State of Ohio, County of Muskingum, Township of Clay, and being part of the northwest quarter of Section 3, Township 14, Range 14, and being part of those lands intended to be described in Deed Volume 1140, page 402; being further bounded and described as follows:

Commencing at an iron pin found at the southwest corner of Lot #8 of Browns Addition to Roseville, as recorded in Plat Book 2, page 120, thence, south 90 degrees – 00 minutes – 00 seconds west, 12.00 feet to an iron pin found, and the **true point of beginning** for the parcel herein intended to be described;

Thence, south 90 degrees – 00 minutes – 00 seconds west, 66.00 feet, along the north line of Fifth Street, to an iron pin found;

Thence, north 00 degrees – 00 minutes – 00 seconds west, 55.42 feet to an iron pin found;

Thence, north 90 degrees – 00 minutes – 00 seconds east, 66.00 feet, along the south line of those lands now or formerly owned by Russell Woodrow, Deed Volume 1157, page 94, to an iron pin found;

Thence, south 00 degrees – 00 minutes – 00 seconds east, 55.42 feet, along the west line of an existing alley, to the **point of beginning**, and **containing 0.084 acres more or less.**

Subject to all legal highways and easements, whether recorded or implied.




