Situated in the State of Ohio, County of Muskingum, Township of Clay, T 14, R 14, Section 3, Village of Roseville and bounded and described as follows:

Commencing at the Southeast corner of Lot 6 of Lenhart Brown Addition to Roseville, Recorded in Plat Book 1, Page 90 of Muskingum County Recorders office; thence North $0^{\circ} 00' 00''$ East 49.50 feet along the West side of Main Street to an iron pin set, the place of beginning; thence North $89^{\circ} 42' 04''$ East 30.00 feet to the center of Main Street; thence along the center of Main Street North $0^{\circ} 00' 00''$ East 66.00 feet to a point; thence South $89^{\circ} 42' 04''$ West 274.90 feet to the center of Zanesville Road passing an iron pin set on the West line of Main Street at 30.00 feet and an iron pin set at 207.17 feet; thence along the center of Zanesville Road South $47^{\circ} 46' 17''$ East 97.64 feet to a point; thence leaving said road North $89^{\circ} 42' 04''$ East 172.60 feet to the place of beginning passing a concrete monument found at 49.35 feet, containing 0.362 acres more or less.

Bearings are based on the North line of Lot 6 of Lenhart Brown Addition bearing North $89^{\circ} 42' 04''$ East.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.




