DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Clay, T-14, R-14, being a part of Thomas L. & Kevin T. Henning Vol. 1100 Pg. 608, being part of Lot 30 in the Village of Roseville, and more particularly described as follows:

Beginning at a 5/8" drilled hole, drilled in concrete at the Northeast corner of Lot 30 of Roseville; thence along the West line of Main Street South 01 Degrees 00 Minutes 21 Seconds East 33.00 feet to a 5/8" hole drilled in concrete; thence North 89 Degrees 44 Minutes 57 Seconds West 111.00 feet to an iron pin set; thence North 01 Degrees 00 Minutes 21 Seconds West 33.00 feet to an iron pin set; thence along the North line of Lot 30 South 89 Degrees 44 Minutes 57 Seconds East 111.00 feet to the place of beginning, containing 0.08 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the North line of Lot 30 as being South 89 Degrees 44 Minutes 57 Seconds East.



