Situated in the State of Ohio, County of Muskingum, Township of T 14, R 14, Southwest Quarter of Section 3, bounded and described as follows:

Parcel One:

Beginning at a stone at the Southeast corner of the Southwest Quarter of Section 3; thence South $89^{\circ} 32'$ West 984.36 feet to an iron pin; thence North $2^{\circ} 50' 48''$ East 148.60 feet to an iron pin; thence North $87^{\circ} 09' 12''$ West 165.00 feet to an iron pin on the East side of a 16.5 foot alley of James Addition to the Village of Roseville; thence along an alley of said Village of Roseville the following six courses and distances, North $2^{\circ} 34'$ East 506.50 feet to an iron pin, North $14^{\circ} 16'$ East 45.00 feet to an iron pin, North $7^{\circ} 28' 40''$ East 252.48 feet to an iron pin, North $31^{\circ} 46' 40''$ East 368.19 feet to an iron pin, North $0^{\circ} 05' 33''$ East 148.50 feet to an iron pin, and North $27^{\circ} 52'$ West 349.67 feet to an iron pin in the center of Brush Creek Road; thence along the center of Brush Creek Road the following four courses and distances, North $70^{\circ} 37'$ East 48.05 feet, North $69^{\circ} 04' 14''$ East 353.71 feet, North $70^{\circ} 29' 48''$ East 562.90 feet and North $80^{\circ} 10' 41''$ East 119.47 feet; thence leaving said road South $5^{\circ} 56'$ West 108.48 feet to a three foot oak tree passing an iron pin at 21.00 feet; thence South $0^{\circ} 16'$ East 1961.91 feet to a stone the place of beginning, containing 45.16 acres more or less.

Bearings of above description are based on the South line of the Southwest Quarter of Section 3 bearing South $89^{\circ} 32'$ West.

Said 45.16 acres parcel includes that section of railroad spur track that runs through said property from Brush Creek Road to the South line of the Southwest Quarter of Section 3. Being the first and second parcel of the first tract of Horizon Coal Company property recorded in Vol. 742, Page 198.


