

## ROBERT B. & MELODY D. KIRKWOOD

Situated in The State of Ohio, County of Muskingum, Township of Clay, Township 14, Range 14, Section 14, bounded and described as follows:

### Parcel 1 (Parcel No. 13-13-60-14-25-000)

Commencing at an iron pin set at the Southeast corner of the Northwest Quarter of Section 14; Thence South  $4^{\circ}10'12''$  West 16.50 feet to a point at The Place of Beginning; Thence continuing South  $4^{\circ}10'12''$  West 262.61 feet to an iron pin set; Thence North  $84^{\circ}37'53''$  West along Catherine Curl, Volume 1025, page 477, 792.00 feet to a point; Thence North  $31^{\circ}40'25''$  East 250.63 feet to a point; Thence South  $87^{\circ}50'27''$  East 676.50 feet to The Place of Beginning.

Beginning at an iron pin set at the Southeast corner of the Northwest Quarter of Section 14; Thence North  $87^{\circ}50'27''$  West 339.77 feet to a point; Thence North  $1^{\circ}29'00''$  East 559.78 feet to a point in East Athens Road (County Rd. 87); Thence along center of Athens Road the next four courses and distances: South  $55^{\circ}53'06''$  East 369.16 feet to a point, South  $56^{\circ}36'31''$  East 125.05 feet to a point, South  $63^{\circ}21'10''$  East 175.45 feet to point, and South  $68^{\circ}55'33''$  East 23.68 feet to a point; Thence leaving East Athens Road, South  $1^{\circ}44'34''$  West 217.57 feet to an iron pin found, passing an iron pin found at 20.00 feet; Thence North  $88^{\circ}11'12''$  West 257.43 feet to The Place of Beginning. Rhodes Family Trust Volume 1147, page 778, North  $3^{\circ}30'33''$  East 494.64 feet to a point; Thence South  $65^{\circ}28'15''$  East 406.61 feet to a point; Thence South  $1^{\circ}29'00''$  West 339.78 feet to The Place of Beginning. Containing 3.68 acres more or less.

### Parcel 4 (13-13-60-14-22-000)

Commencing at an iron pin set at the Southeast corner of the Northwest Quarter of Section 14; North  $87^{\circ}50'27''$  West 731.44 feet to an iron pin found; Thence North  $3^{\circ}30'33''$  East 494.64 feet to a point at The Place of Beginning; Thence continuing North  $3^{\circ}30'33''$  East 220.00 feet to a point in East Athens Road (County Road 87); Thence along center of East Athens Road the next five courses and distances: South  $66^{\circ}42'33''$  East 32.35 feet to a point, South  $66^{\circ}33'14''$  East 98.90 feet to a point, South  $65^{\circ}44'00''$  East 98.01 feet to a point, South  $64^{\circ}48'21''$  East 95.27 feet to point, and South  $61^{\circ}46'54''$  East 75.05 feet to a point; Thence leaving East Athens Road South  $1^{\circ}29'00''$  West 220.00 feet to a point; Thence North  $65^{\circ}28'15''$  West 406.61 feet to The Place of Beginning.  Section 14.




