Commencing at a stone found at the Southwest corner of Section 14; Thence North 89°41'00" East along Morgan County line 357.00 feet to a point in Elks Run Road; Thence North 05°06'00" East 75.23 feet to a point in said road; Thence continuing along Elks Run Road, North 14°33'54" West 403.75 feet to a spike set at the intersection of Watts Road, the place of beginning; Thence along the center of Elks Run Road, the following four courses and distances – North 23°33'51" West 101.95 feet to a point, North 27°49'33" West 111.95 feet to a point in Elks Run Road, North 22°45'38" West 96.41 feet to a point, and North 23°07'35" West 39.00 feet to a point in said road; Thence leaving said road South 72°28'29" East along the split line of Deed Volume 563, page 99 1573.29 feet to an iron pin set passing an iron pin set at 15.00 feet; Thence along the split line South 16°51'09" West 54.97 feet to a point in the center of Watts Road passing an iron pin set at 32.23 feet; Thence along the center of Watts Road and Larry Miller Deed Volume 685, page 101, the next thirteen courses and distances – South 71°41'35" West 111.94 feet to a point, South 66°36'24" West 110.45 feet to a point, South 74°26'15" West 65.18 feet to a point, South 81°59'55" West 55.45 feet to a point, South 85°36'04" West 70.92 feet to a point, South 89°36'59" West 327.29 feet to a point, North 89°58'10" West 76.43 feet to a point, North 81°48'45" West 67.72 feet to a point, North 69°19'59" West 50.89 feet to a point, North 61°01'19" West 75.64 feet to a point, North 52°21'47" West 156.36 feet to a point, North 52°02'26" West 223.70 feet to a point, and North 67°47'48" West 62.56 feet to the place of beginning containing 10.00 Acres more or less.


Bearings are based on the South line of Section 14 bearing North 89°41'00" East.






