

Description of Parcel 2

Situated in the State of Ohio, County of Muskingum, Township of Clay, being in the southeast quarter of Section 14, Range 14 West, Township 14 North, of "The Congress Lands East of the Scioto River", and being bounded and described as follows:

Commencing for Reference at an iron pin found at the southeast corner of Section 14 and the southwest corner of Section 13, said iron pin being in the county line between Muskingum County and Morgan County;

thence, with the south line of Section 14, the county line, and the north line of a 20 acres tract and a 42.530 acres tract as conveyed to Floyd H. Harker by Deed Volume 137, Page 571 of the Morgan County Recorder's Office, North $89^{\circ}16'41''$ West a distance of 1,968.12 feet to an iron pin set at the southeast corner of a 39.02 acres tract as conveyed to Michael Inman by Deed Volume 950, Page 264 of the Muskingum County Recorder's Office;

thence, with the east line of said Inman property, North $00^{\circ}24'55''$ East a distance of 323.00 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the east line of said Inman property, North $00^{\circ}24'55''$ East a distance of 323.00 feet to an iron pin set;

thence, leaving the property line, South $88^{\circ}45'26''$ East a distance of 1,828.23 feet to a point in the centerline of County Road No. 87 (East Athens Road), passing through two iron pins set at distances of plus 1,699.90 feet and 1,799.90 feet, respectively;

thence, with the centerline of County Road No. 87 and the west line of a 19.870 acres tract as conveyed to J. Robert Bromley by Deed Volume 1051, Page 363 of the Muskingum County Recorder's Office, South $14^{\circ}53'55''$ East a distance of 294.59 feet to a point;

thence, leaving the road, North $89^{\circ}57'35''$ West a distance of 1,905.88 feet to the Point of Beginning, passing through two iron pins set at distances of plus 23.61 feet and plus 123.61 feet, respectively;

containing 13.004 acres, more or less, being a new split out of Parcel No. 13-13-60-14-41-000.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.

Subject to the right-of-way of County Road No. 87.

Subject to a 40.00 feet wide easement being reserved unto the grantor, his heirs, and/or assigns, forever. Said easement is for the purposes of running utilities to other parcels of land on or near County Road No. 87. Said easement runs in a north-south direction across the east end of the above described property with the east line of said easement being the centerline of County Road No. 87. Containing 0.271 acres, more or less, of easement.

Coal rights only are excepted having been previously transferred by predecessor in title.

Subject to any facts that may be disclosed in a full and accurate title search.

All iron pins set are rebar with yellow caps labeled "Claus 6456".

The bearings in this description are for angle calculations only and are based on the south line Sections 13 and 14 used as an assumed bearing of North 89°16'41" West as described in Deed Volume 1051, Page 363 of the Muskingum County Recorder's Office.

SURVEY PLAT for BRUNER LAND CO.

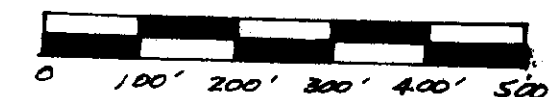

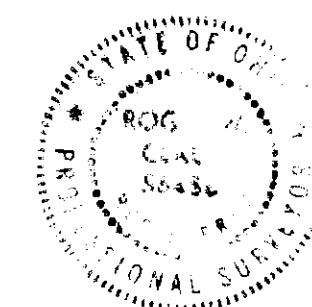
