thence, with the south line of the southwest quarter of the northeast quarter, North 86°09'50" West a distance of 774.88 feet to a 5/8" iron pin set in the south line of a 0.91 acre tract as conveyed to Jimmy Lee Stidham by Official Records Volume 356, Page 2694 of the Perry County Recorder's Office;

thence, with the east line of said Stidham property and an extension thereof, North 61°24'20" East a distance of 417.57 feet to a 5/8" iron pin found uncapped on the south side of an existing private road (being stated in current deeds and surveys of record as a 16.00 feet wide reserved roadway) at the northeast corner of a 0.94 acre tract as conveyed to Jimmy Lee Stidham by Official Records Volume 422, Page 1493 of the Perry County Recorder's Office, passing through a 1" bolt found at a distance of plus 150.58 feet;
