Situated in the State of Ohio, County of Muskingum, Township of Clay, being in the east half of the northeast quarter of Section 13, Range 14 West, Township 14 North, of "The Congress Lands East of The Scioto River" and being bounded and described as follows:

Commencing for reference at an iron pin set at the northeast corner of Section 13 (Note: Reference bearing on the east line of Section 13 used as South 01°15'17" West.);

thence, with the north line of Section 13, North 89°22'48" West a distance of 1,041.78 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning leaving the section line, South 02°23'32" East a distance of 1,305.37 feet to a point in the centerline of Township Road No. 134 (Goose Creek Road), passing through two iron pins set at distances of plus 1,183.70 feet and plus 1,283.70 feet, respectively;

thence, with the centerline of Township Road No. 134, South 57°35'54" West a distance of 256.20 feet to a point in the centerline intersection with Township Road No. 146 (Spring Road);

thence, with the centerline of Township Road No. 146, the following two courses:

- (1) North 45°03'21" West a distance of 42.66 feet to a point;
- (2) thence North 58°46'43" West a distance of 51.34 feet to a point in the centerline intersection with Township Road No. 132 (Rider Road);

thence, with the centerline of Township Road No. 132, North 59°22'24" West a distance of 82.84 feet to a point in the west line of the east half of the northeast quarter of Section 13;

thence, with the quarter-quarter section line, North 01°19'46" East a distance of 1,345.91 feet to an iron pin found capped "C.R. Harkness LS-6885" at the northwest corner of the east half of the northeast quarter of Section 13, passing over the centerline of Township Road No. 146 at distances of plus 118.00 feet and plus 1,007.46 feet, respectively and passing through four iron pins set at distances of plus 68.00 feet, plus 168.00 feet, plus 967.46 feet, and plus 1,047.46 feet, respectively;
