## DEED DESCRIPTION

SITUATED IN THE SOUTH HALF OF QUARTER TOWNSHIP 2, TOWNSHIP 1N, RANGE 8W, FALLS TOWNSHIP, MUSKINGUM COUNTY, OHIO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEING A SURVEY OF A PART OF A 114.50 ACRE PARCEL CONVEYED TO ELMER O. AND VIRGINIA HOLBEIN, AS RECORDED IN DEED VOLUME 727, PAGE 212, IN THE MUSKINGUM COUNTY RECORDER'S OFFICE, AND FURTHER DESCRIBED AS FOLLOWS:

BEGINNING FOR REFERENCE AT AN IRON PIN SET MARKING THE NORTHEAST CORNER OF LOT 4 OF JOHN ROBERTS SURVEY, AS RECORDED IN DEED BOOK 2, PAGE 366, BEING THE NORTHEAST CORNER OF SAID 114.50 ACRE PARCEL CONVEYED TO HOLBEIN, BEING THE SOUTHEAST CORNER OF A 2.00 ACRE PARCEL CONVEYED TO CARLOS L. AND DOROTHY J. ALLEN, AS RECORDED IN DEED VOLUME 475, PAGE 643, BEING ON THE SOUTH LINE OF LOT 3, OF SAID JOHN ROBERTS SURVEY, BEING ON THE EAST LINE OF QUARTER TOWNSHIP 2, BEING IN THE RIGHT OF WAY OF BARKERS RUN ROAD (MUSKINGUM CO. ROAD 407), AND BEING THE NORTHEAST CORNER AND PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED;

THENCE WITH THE EAST LINE OF QUARTER TOWNSHIP 2, THE SAME BEING THE EAST LINE OF SAID LOT 4 AND THE EAST LINE OF SAID 114.50 ACRE PARCEL CONVEYED TO HOLBEIN, S 03° 12'00" W 50.00 FEET TO AN IRON PIN SET, AND BEING THE SOUTHEAST CORNER OF THE TRACT HEREIN DESCRIBED:




