

Re-Survey of William K., Daniel Francis, and Michael Anthony Metzger Lands in Falls  
Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Falls, and being part of Lot 17, and part of Lot 18 in Bank Lots (DR "K" Pg. 644), Township 1, Range 8, United States Military Lands, and being all of the lands presently owned by William K. Metzger, Daniel Francis Metzger, and Michael Anthony Metzger, as per Official Record 1602, Page 474, First Parcel, and Second Parcel, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an axle found at the northwest corner of Lot 18, of Bank Lots (DR "K" pg. 644);

Thence along the west line of Lot 17, of said Bank Lots, North 03 degrees 00 minutes 33 seconds East, 174.99 feet to an iron pipe found on the southwest corner of lands presently owned by Lisa K. Moore, Trustee, (OR 2351-236);

Thence along the south lines of said Moore lands, the following nine courses:

- 1.) South 87 degrees 14 minutes 37 seconds East, 109.00 feet to a point in the center of Bartlett Run, from which an iron pipe found bears North 37 degrees 17 minutes 48 seconds West, 26.25 feet;
- 2.) Along the center of said Bartlett Run, North 38 degrees 13 minutes 31 seconds East, 44.02 feet to a point;
- 3.) Along the center of said Bartlett Run, North 85 degrees 23 minutes 55 seconds East, 107.12 feet to a point;
- 4.) Along the center of said Bartlett Run, South 77 degrees 54 minutes 42 seconds East, 83.95 feet to a point;
- 5.) Along the center of said Bartlett Run, South 76 degrees 51 minutes 22 seconds East, 31.99 feet to a point;
- 6.) Thence leaving the center of said Bartlett Run, South 87 degrees 42 minutes 18 seconds East, 85.66 feet to an iron pipe found;
- 7.) South 87 degrees 58 minutes 41 seconds East, 53.58 feet to an iron pipe found;
- 8.) South 03 degrees 01 minutes 14 seconds West, 200.13 feet to a iron pin found on the north line of Lot 18 of said Bank Lots;
- 9.) Along the north line of said Lot 18 of Bank Lots, South 88 degrees 02 minutes 38 seconds East, 755.59 feet to an iron pipe found, (3 in' dia.), on a northwest corner of lands presently owned by Marvin D. and Maryann Troyer, (OR 2422-21);

Thence along the west line of said Troyer lands, South 01 degrees 40 minutes 27 seconds West, 342.41 feet to an iron pipe found on the northeast corner of lands presently owned by John E. Krofft, (DR 1117-488);

Thence along the north line of said Krofft lands, North 87 degrees 50 minutes 54 seconds West, 823.13 feet to an axle found on the northeast corner of lands also presently owned by John E. Krofft, (DR 580-688);

Thence along the north line of said Krofft lands, and the north line of lands presently owned by Jay A. Larson, (OR 1590-690), North 88 degrees 12 minutes 38 seconds West, 434.59 feet to a point on the west line of Lot 18 of said Bank Lots, and passing an iron pin found at 174.16 feet, the property line at 222.02 feet, an iron pin found at 252.17, an axle found at 384.75 feet,
