Beginning at a point marked by an existing iron pin (axle) at the Easterly most Corner of Lot number 22 of Valley View Village Number two as recorded in Plat Book nine, page 39 of the Muskingum County Plat Records; thence North 38 degrees 38 minutes 13 seconds West 60.06 feet along the Northerly line of said lot number 22 to a point marked by an existing iron pin (axle); thence leaving the said Northerly line of lot number 22 North 13 degrees 30 minutes 00 seconds East 92.45 feet to a point marked by an iron pin; thence North 89 degrees 29 minutes 28 seconds East 220.70 feet to a point marked by an existing iron pin (steel Rod) on the West right-of-way of Arc Drive; thence South 00 degrees 30 minutes 32 seconds East 96.58 feet along the said West right-of-way of Arc Drive to a point marked by an iron pin; thence South 89 degrees 29 minutes 28 seconds West 168.63 feet to a point marked by an iron pin; thence South 42 degrees 17 minutes 00 seconds West 55.00 feet to the place of beginning.
