

Survey for Ohio Franklin Realty, LLC

Being a part of land located in the State of Ohio, County of Muskingum, Harrison Township and the Village of Philo, part of the south half of Section 30, Township 13 North, Range 12 West, Congress Lands East of the Scioto River.

Being part of the lands conveyed to Ohio Franklin Realty, LLC, in the following instruments:

Commencing at a concrete monument found at the southwest corner of Lot 11 in Square 30 in a plat of an addition of the north side of the Town of Taylorsville (Deed Record "X", page 397);

thence along the west line of Square 30 North 07 degrees 38 minutes 21 seconds West 236.67 feet to a concrete monument found;

thence continuing along the west line of Square 30, North 07 degrees 38 minutes 21 seconds West 86.45 feet to a point, being the northwest corner of Lot 17 in said Square 30, the **place of beginning** for this parcel;

thence leaving the west line of Square 30 and along the south line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 82 degrees 20 minutes 27 seconds West 192.00 feet to an iron pin set, being the southwest corner of Ohio Franklin Realty (DR 2566-383, tract 4, parcel 1);

thence leaving Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) and through Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 2 and tract 3 parcel 6) the following four courses:

1. North 70 degrees 07 minutes 31 seconds West 559.57 feet to an iron pin set;
2. North 83 degrees 37 minutes 43 seconds West 915.61 feet to an iron pin set;
3. North 78 degrees 13 minutes 58 seconds West 1080.32 feet to an iron pin set;
4. North 55 degrees 58 minutes 29 seconds West 193.02 feet to an iron pin set on the west line of Ohio Franklin Realty, LLC (DR 2566-383, tract 3, parcel 6);

thence along the west line of Ohio Franklin Realty, LLC (DR 2566-383, tract 3, parcel

6) North 02 degrees 36 minutes 41 seconds East 347.36 feet to a mag nail set in the existing centerline of Old River Road (County Road 6);

thence along the existing centerline of Old River Road (County Road 6) the following seventeen courses:

8. South 84 degrees 11 minutes 54 seconds East 95.00 feet to a point;
9. South 88 degrees 15 minutes 16 seconds East 161.96 feet to a mag nail set;
10. South 86 degrees 13 minutes 56 seconds East 56.99 feet to a point;
11. South 82 degrees 39 minutes 59 seconds East 86.18 feet to a point;
12. South 81 degrees 56 minutes 06 seconds East 378.87 feet to a point;
13. South 79 degrees 52 minutes 15 seconds East 224.00 feet to a point;
14. South 77 degrees 16 minutes 56 seconds East 274.45 feet to a point;
15. South 74 degrees 11 minutes 27 seconds East 140.29 feet to a mag nail set;
16. On a curve to the right having a radius of 800.00 feet, a delta of 21 degrees 33 minutes 17 seconds, a chord bearing and distance of South 63 degrees 24 minutes 49 seconds East 299.19 feet to a mag nail set;
17. South 52 degrees 38 minutes 10 seconds East 11.99 feet to a point;

thence leaving the centerline of Old River Road (County Road 6) and along the east line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 07 degrees 39 minutes 35 seconds East 125.86 feet to a point;

thence continuing along the east line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 07 degrees 39 minutes 35 seconds East 23.26 feet to a concrete monument found;

thence continuing along the east line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 07 degrees 39 minutes 35 seconds East 134.45 feet to a concrete monument found disturbed, being the southeast corner of Ohio Franklin Realty, LLC (DR 2566-383);

thence along the south line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 82 degrees 20 minutes 27 seconds West 19.91 feet to a concrete monument found;

thence continuing along the south line of Ohio Franklin Realty, LLC (DR 2566-383, tract 4, parcel 1) South 82 degrees 20 minutes 27 seconds West 138.09 feet to the place of beginning containing 28.37 acres, more or less.

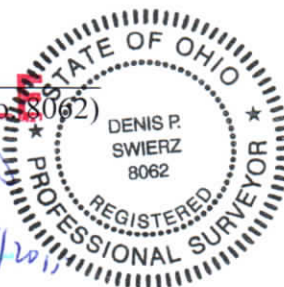

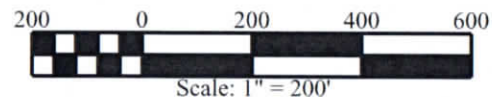
