BEING A PART OF THE TRACT CONVEYED TO WILLIAM H. AND SANDRA F. BURCKHOLTER (DEED VOLUME 1157, PAGE 125 OF THE MUSKINGUM COUNTY DEED RECORDS) AND SITUATED IN THE SOUTHWEST QUARTER OF SECTION 6, TOWNSHIP 12, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIO, HARRISON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (5/8 INCH REBAR AT THE SOUTHWEST CORNER OF SECTION 6;

THENCE WITH THE WEST LINE OF THE SAID SOUTHWEST QUARTER AND THE EAST LINE OF A TRACT CONVEYED TO JON FOX (DEED VOLUME 943, PAGE 275), NORTH 00 DEGREES 13 MINUTES 34 SECONDS WEST 612.37 FEET TO AN EXISTING STONE, PASSING EXISTING IRON PINS (5/8 INCH REBAR) AT 24.40 FEET AND 341.97 FEET;

THENCE CONTINUING WITH THE SAID WEST LINE OF THE SOUTHWEST QUARTER AND WITH THE EAST LINE OF A TRACT CONVEYED TO JON FOX (O.R. VOLUME 1934, PAGE 389), NORTH 00 DEGREES 36 MINUTES 05 SECONDS WEST, PASSING IRON PINS SET AT 408.82 FEET AND 1262.20 FEET, A TOTAL DISTANCE OF 1355.07 FEET TO AN IRON PIN SET, SAID IRON PIN BEING SOUTH 00 DEGREES 36 MINUTES 05 SECONDS EAST 360.00 FEET FROM AN EXISTING CONCRETE MONUMENT AT THE CENTER OF A TRACT CONVEYED TO THE OHIO POWER COMPANY (DEED VOLUME 281, PAGE 538);

THENCE WITH THE EAST LINE OF A TRACT CONVEYED TO J. AND B. RANEY (O.R. VOLUME 1990, PAGE 792), NORTH 37 DEGREES 10 MINUTES 55 SECONDS EAST 902.73 FEET TO AN IRON PIN SET ON THE NORTH LINE OF THE SAID SOUTHWEST QUARTER;

THENCE WITH THE SAID NORTH LINE OF THE SAID SOUTHWEST QUARTER AND THE SOUTH LINE OF A TRACT CONVEYED TO J. AND D. KIRK (O.R. VOLUME 2124, PAGE 616), NORTH 89 DEGREES 59 MINUTES 50 SECONDS EAST 2193.07 FEET TO AN EXISTING IRON PIN (1/2 INCH PIPE), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 113.06 FEET AND 1893.07 FEET AND IRON PINS SET AT 591.47 FEET AND 1479.47 FEET;

THENCE WITH THE EAST LINE OF THE SAID SOUTHWEST QUARTER, SOUTH 00 DEGREES 27 MINUTES 40 SECONDS WEST 945.18 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 254.50 FEET;

THENCE CONTINUING WITH THE SAID EAST LINE OF THE SAID SOUTHWEST QUARTER, SOUTH 00 DEGREES 12 MINUTES 05 SECONDS WEST 1705.82 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), PASSING AN IRON PIN SET AT 1025.50 FEET;

THENCE WITH THE SOUTH LINE OF THE SAID SOUTHWEST QUARTER AND THE NORTH LINE OF A TRACT CONVEYED TO S. AND P. BELL (O.R. VOLUME 1717, PAGE 766), SOUTH 89 DEGREES 14 MINUTES 39 SECONDS WEST 1076.23 FEET TO AN EXISTING RAILROAD SPIKE IN THE CENTER OF TOWNSHIP ROAD 68 (BUTTERBEAN RIDGE ROAD) AT THE SOUTHEAST CORNER OF A 1.95 ACRE TRACT CONVEYED TO HOLLY N. BURCKHOLTER (O.R. VOLUME 2183, PAGE 437);

THENCE WITH THE EAST LINE OF THE SAID 1.95 ACRE TRACT AND WITH THE CENTERLINE OF SAID ROAD THE FOLLOWING THREE COURSES AND DISTANCES:

- 1. SOUTH 89 DEGREES 14 MINUTES 40 SECONDS WEST 202.03 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 34.75 FEET;**
- 2. SOUTH 00 DEGREES 45 MINUTES 20 SECONDS EAST 382.07 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);**
