

## Survey for Alberta Newman

Being all of a tract of land conveyed to Alberta Newman from Raymond G. Mayle and Naomi Mayle as described in Deed Volume 495 - Page 114 and recorded in the Muskingum County Recorder's Office.

Located in the Southwest 1/4 of the Northeast quarter of Section 6, Township 12, Range 12, Harrison Township, Muskingum County, State of Ohio.

Commencing at a 5/8 inch rebar pin set at a fence corner marking the Northwest corner of the Southwest 1/4 of the Northeast quarter of Section 6; thence along a fence line South 85 deg. 38 min. 50 sec. East - 886.12 ft. to the center of Township Road No. 68 - Butterbean Ridge Road ( ref. passing over 5/8 inch rebar pins set at 312.01 ft. and at 844.14 ft.); thence from this true place of beginning and leaving the road and continuing along a fence line South 85 deg. 38 min. 50 sec. East - 469.11 ft. to a fence corner; thence along a fence line South 03 deg. 45 min. West - 1023.00 ft. to a fence corner ( ref. passing over an axle found at 968.69 ft.); thence along a fence line North 86 deg. 07 min. 40 sec. West - 1011.50 ft. to the center of Township Road No. 68 ( ref. passing over a 5/8 inch rebar pin set at 996.50 ft.); thence along the center of the road North 17 deg. 22 min. 35 sec. East - 204.61 ft. to a mag nail set; thence North 08 deg. 54 min. 31 sec. East - 143.55 ft. to a mag nail set; thence North 19 deg. 51 min. 09 sec. East - 66.38 ft. to a mag nail set; thence North 39 deg. 53 min. 15 sec. East - 53.63 ft. to a mag nail set; thence North 55 deg. 43 min. 31 sec. East - 82.33 ft. to a mag nail set; thence North 63 deg. 46 min. 15 sec. East - 216.43 ft. ( ref. 5/8 inch rebar pin set North 52 deg. 26 min. 27 sec. West - 23.00 ft.); thence continuing along the center of the road North 41 deg. 10 min. 22 sec. East - 103.96 ft. to a PK nail set; thence North 18 deg. 24 min. 51 sec. East - 245.96 ft. to a PK nail set; thence North 32 deg. 30 min. 09 sec. East - 111.21 ft. to the place of beginning and containing 18.09 acres, more or less by this survey ( 17.94 acres by deed) Being all of Auditor's Parcel No. 20-40-06-28-000

Bearings are to an assumed meridian and are used to denote angles only.

The above described tract being subject to all easements, easements right-of-ways and restrictions of legal record and those that might exist on the property.

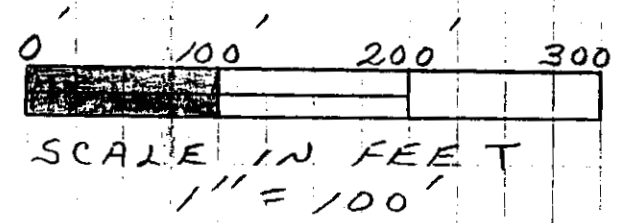
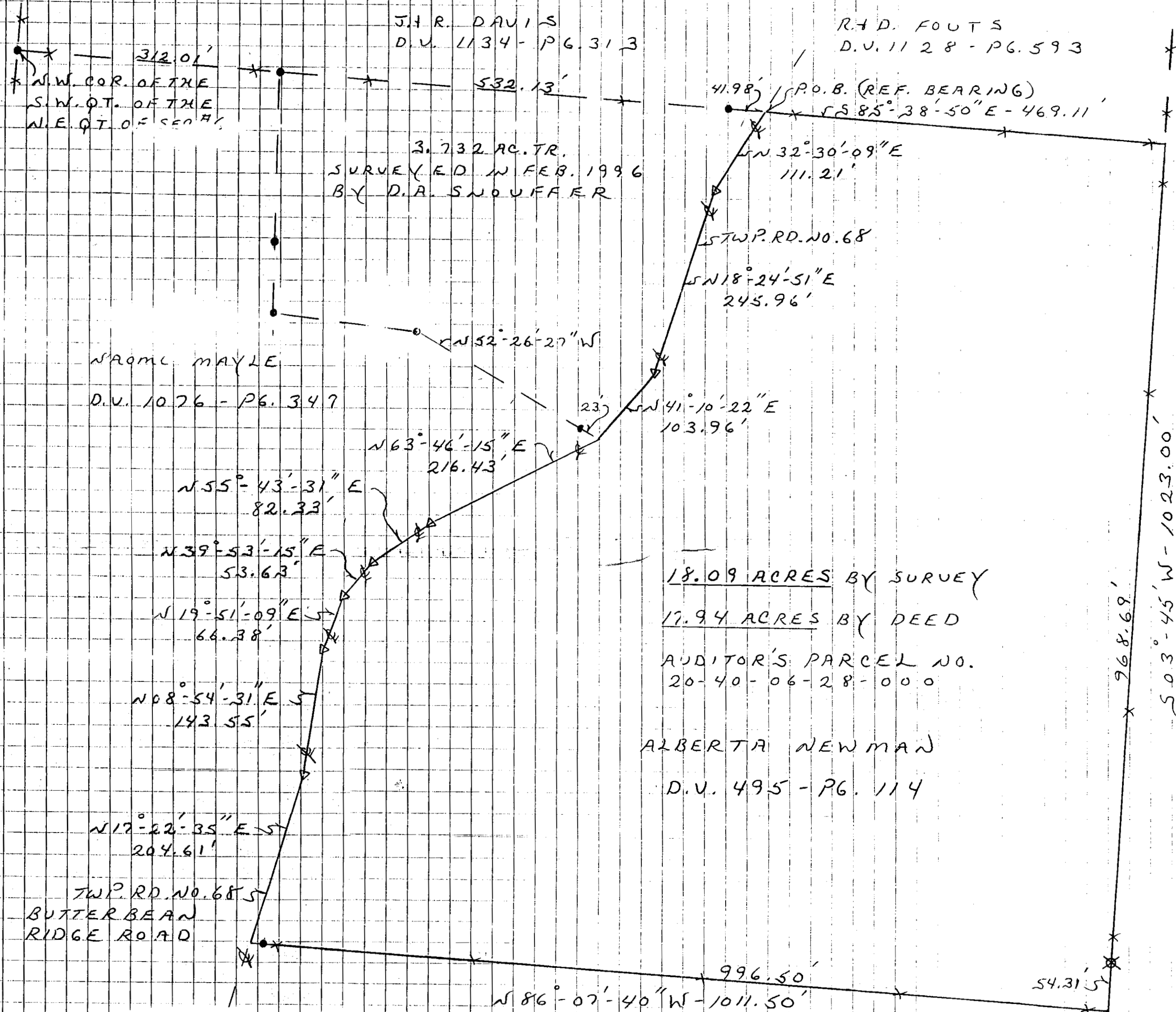

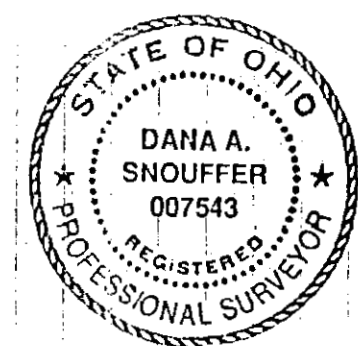
