**Legal Description for Parcel 20-50-30-10-000  
1975 Back Run Road**

**Situated in the Township of Harrison, County of Muskingum and State of Ohio, being part of the West Half of the Northwest Quarter of Section 30, Township 11, Range 13 and being further bounded and described as follows:**

**Commencing at a Chiseled X in a Stone found at the Southwest Corner of the Northwest Quarter of Section Number 30;**

**Thence North 00° 11'45" West along the Westerly line of said Section Number 30, a distance of 421.67 feet to a Northwesterly corner of a 68.884 acre parcel of land conveyed to Kevin Komaromy and Kelly Komaromy (O.R. Volume 1019, Page 269) and being the Point of Beginning of the Parcel herein described.**

**Course Number 1: Thence North 00° 11'45" West continuing along the Westerly line of said Section Number 30, a distance of 703.34 feet to a Southwesterly corner of said 68.884 acre parcel of land conveyed to Kevin Komaromy and Kelly Komaromy (O.R. Volume 1019, Page 269);**

**Course Number 2: Thence North 89° 56'06" East along a Southerly line of said lands conveyed to Kevin Komaromy and Kelly Komaromy, passing through a 5/8" iron pin found at a distance of 23.59 feet, a total distance of 186.44 feet to a 5/8" iron pin found at an interior corner thereof;**

**Course Number 3: Thence South 06° 59'24" East along a Westerly line of said lands conveyed to Kevin Komaromy and Kelly Komaromy, a distance of 707.90 feet to a 5/8" iron pin found at an interior corner thereof;**

**Course Number 4: Thence South 89° 48'24" West along a Northerly line of said lands conveyed to Kevin Komaromy and Kelly Komaromy, passing through a 5/8" iron pin found at a distance of 248.39 feet, a total distance of 270.18 feet to the Point of Beginning and containing 160,522 Square Feet or 3.6851 Acres of land more or less, as surveyed and described by Scott J. Casey, Professional Surveyor Number 8219 on June 3rd of 2014 and being subject to the right-of-way of Back Run Road ( Township Road 140), all legal highways, easements, reservations or restrictions of record.**

**Bearings are based on the Centerline of Back Run Road, North 00° 11'45" West, as described in O.R. Volume 1019, Page 269.**

**All iron pins set are 5/8" diameter by 30" long rebar with plastic identification caps reading "Casey, P.S. 8219".**

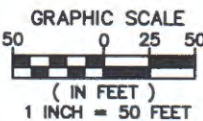
