Description of Parcel 10

Situated in the State of Ohio, County of Muskingum, Township of Harrison, being in the southwest quarter of Section 21, Range 13 West, Township 11 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at a marked stone found at the center of Section 21;

thence, with the north line of the southwest quarter of Section 21, South $89^{\circ}52'52''$ West a distance of 590.24 feet to an iron pin set at the northwest corner of a 30.000 acres tract as conveyed to M. Tank by Deed Volume 541, Page 642 of the Muskingum County Recorder's Office;

thence, with the west line of said 30.000 acres tract, South $00^{\circ}45'47''$ East a distance of 1,361.74 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the west line of said 30.000 acres tract, South $00^{\circ}45'47''$ East a distance of 890.00 feet to an iron pin set at a marked stone found at the southwest corner of said 30.000 acres tract;

thence, leaving the property line, North $56^{\circ}51'41''$ West a distance of 1,290.76 feet to an iron pin set in the centerline of Township Road No. 484, passing through three iron pins set at distances of plus 901.22 feet, plus 1,101.22 feet, and plus 1,240.76 feet, respectively;

thence, with the centerline of Township Road No. 484, the following two courses:

- (1) North $29^{\circ}50'34''$ West a distance of 95.95 feet to an iron pin set;
- (2) thence North $37^{\circ}27'38''$ West a distance of 111.38 feet to an iron pin set;

thence, leaving the road, North $89^{\circ}23'14''$ East a distance of 1,184.53 feet to the Point of Beginning, passing through two iron pins set at distances of plus 30.00 feet and plus 230.00 feet, respectively;

containing 13.278 acres, more or less.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.


