

bounded and described as follows:


Commencing at the southwest corner of the Northwest
quarter of said Section 20; thence north along the section
line between Sections 19 and 20 a distance of one thousand
fifty-six (1056) feet to a point in the center of the
Virginia Ridge Road; thence along said center of said road
south 83 degrees 15 minutes east 792 feet to a point in
said road; thence south 84 degrees 15 minutes east 370.26
feet to a point in said road; thence north 57 degrees 15
minutes east 264 feet to a point in said road; thence south
73 degrees 30 minutes east 924 feet to a point in Old River
Road; thence south 79 degrees 0 minutes east 478.36 feet
to a point in road; thence north 74 degrees 6 minutes east
107.75 feet to a point in road; thence north 38 degrees
44 minutes east 130.38 feet to a point in road; thence north
16 degrees 21 minutes east 219.75 feet to a point in road;
thence north 4 degrees 59 minutes east 271.40 feet to a
point in road; thence north 21 degrees 57 minutes east 379.80
feet to a point in said road; thence north 15 degrees 08
minutes east 75.0 feet to the true place of beginning of
the premises herein intended to be described; thence north
15 degrees 08 minutes east 75.0 feet to a point in Old River
Road; thence leaving said road south 74 degrees 52 minutes
east 66.0 feet to the low water mark of the Muskingum River
passing iron pin found at 19.79 feet and at 45.84 feet;
thence down said low water mark south 17 degrees 02 minutes
west 75.04 feet to a point; thence leaving said low water
mark, and along the north line of property conveyed to Brian
P. Masters by deed recorded in Deed Book 2041, Page 850
north 74 degrees 52 minutes west 63.51 feet to the true
place of beginning passing an iron pin found at 44.39 feet,
containing eleven hundredths (0.11) of an acre more or less.


