- #3- THENCE with a curve to the right having, a chord bearing South 53 degrees 28 minutes 22 seconds West 210.44 feet, a radius of 1093.50 feet, and arc length of 210.77 feet continuing along said road and properties to an unmarked point;

- #10- THENCE South 76 degrees 11 minutes 12 seconds West 1320.71 feet crossing the East Half of the North West Quarter of Section 14, and along said Komaromy and Warpool properties to a tree stump (found) on the common line for the East and West Halves of the Northwest Quarter of Section 14, passing iron pins (found) capped Linn at 15.38 feet and 1315.58 feet;
- #11- THENCE South 02 degrees 46 minutes 16 seconds West 1169.39 feet along said Mid Quarter Section line and continuing along said properties to an iron pin (set) at the common corner for the East and West Halves of the Northwest and Southwest Quarters of Section 14;
