Parcel Two

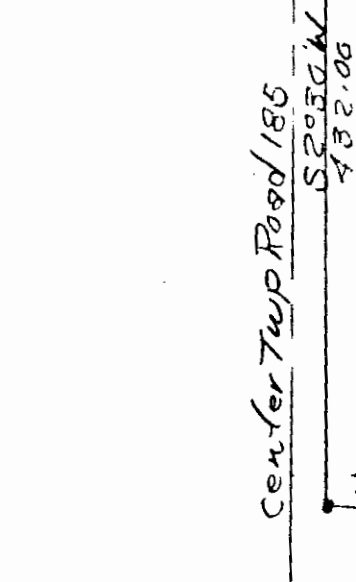

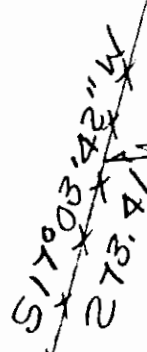
