

Being 2.208 acres, more or less (1.217 acres, part of # 25-25-16-04-22 and 0.991 acres, part of # 25-25-16-04-21) in the southeast quarter of section 4, in the second quarter of township 1 north, range 9 west, United States Military Lands, in the township of Hopewell, in the county of Muskingum, in the State of Ohio, and more particularly described as follows:

Commencing at a 3/4" pipe found at the southeast corner of Section 4;

thence, along the section line (sections 3 & 4) N.00°06'15"E. 331.74' to a 3/4" pipe found;

thence, along the property line of B.J. Lewis, 1125/631 and Cassandra Holderman, 1118/80, S.89°31'42"W. 434.13' to a 3/4" pipe found, said 3/4" pipe found being the TRUE POINT OF BEGINNING;

thence, continuing along the property line of Cassandra Holderman, 1118/80 the following 2 courses:

- 1. thence, S.00°04'45"E. 195.41' to a 5/8" rebar found;
- 2. thence, continuing S.00°04'45"E. 30.00' to a point in Hidden Springs Road, TR 292;

thence, along the centerline of Hidden Springs Road, TR 292, the following 4 courses:

- 1. thence, N.81°15′51"W. 100.30' to a point;
- 2. thence, N.83°17'19"W. 75.69' to a point;
- 3. thence, N.87°54'37"W. 67.08' to a point;
- thence, S.88°55'58"W. 14.17' to a point;

thence, through the property of Sharon A. Wince, 877/208, 640/297, the following 3 courses:

- 1. thence, N.00°04'45"W. 88.02' to a 5/8" steel pin set;
- 2. thence, continuing N.00°04'45"W. 279.02' to a 5/8" steel pin set;
- 3. thence, N.89°57'52"E. 255.47' to a 5/8" steel pin set;

thence, along the property line of B.J. Lewis, 1125/631, S.00°04'45"E. 168.05' to the TRUE POINT OF BEGINNING, containing 2.208 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.
