Survey Split of Robert H. Miller III Lands in Hopewell Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of the Southeast Quarter of Section 7, Township 1, Range 9, United States Military Lands, and being part of the lands presently owned by Robert H. Miller III, as per Official Record 3004, Page 805, (Tract I) and being more particularly described as follows:

Beginning for reference at a stone found on the northeast corner of the Southeast Quarter of Section 7, Township 1, Range 9, United States Military Lands;

Thence along the section line, South 02 degrees 50 minutes 01 seconds West, 1123.16 feet to a point on the northeast corner of lands presently owned by David M. and Marci L. Worstell, (OR 1941-498), (from which an iron pin found bears North 88 degrees 05 minutes 52 seconds East, 0.44 feet, and an axle found bears South 84 degrees 42 minutes 02 seconds East, 1.45 feet), passing an iron pin found at 222.04 feet, and an iron pin set at 325.69 feet;

Thence along the north lines of said Worstell lands the following four courses;

- 1.) North 84 degrees 42 minutes 10 seconds West, 135.00 feet to an iron pin set;
- 2.) North 76 degrees 46 minutes 51 seconds West, 125.10 feet to an axle found;
- 3.) North 73 degrees 58 minutes 21 seconds West, 55.14 feet to an axle found;
- 4.) South 66 degrees 04 minutes 45 seconds West, 115.67 feet to an iron pin set, and the principal place of beginning;

Thence continuing along the north line of said Worstell lands, the following seven courses:

- 1.) South 66 degrees 04 minutes 45 seconds West, 45.74 feet to an axle found;
- 2.) South 72 degrees 08 minutes 17 seconds West, 66.13 feet to an axle found;
- 3.) South 63 degrees 54 minutes 40 seconds West, 90.21 feet to an iron pin set;
- 4.) South 73 degrees 46 minutes 28 seconds West, 121.26 feet to an axle found;
- 5.) South 50 degrees 31 minutes 58 seconds West, 71.23 feet to an axle found;
- 6.) South 57 degrees 17 minutes 41 second West, 148.29 feet to an axle found;
- 7.) South 65 degrees 02 minutes 29 seconds West, 220.54 feet to an iron pin found on the southeast corner of lands presently owned by John Brown Jr., (OR 2921-321);
