Survey Remainder of Robert H. Miller III Lands in Hopewell Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being part of the Southeast Quarter of Section 7, Township 1, Range 9, United States Military Lands, and being part of the lands presently owned by Robert H. Miller III, as per Official Record 3004, Page 805, (Tract I), and being more particularly described as follows:

Beginning for reference at a stone found on the northeast corner of the Southeast Quarter of Section 7, Township 1, Range 9, United States Military Lands;

Thence along the section line, South 02 degrees 50 minutes 01 seconds West, 287.27 feet to a point in the centerline of Macedonia Road, (Twp. Rd. 122, R\W 40'), and the principal place of beginning, passing an iron pin found at 222.04 feet;

Thence continuing along the section line, South 02 degrees 50 minutes 01 seconds West, 835.89 to a point, on the northeast corner of lands presently owned by David M. and Marci L. Worstell, (OR 1941-498), (from which an iron pin found bears North 88 degrees 05 minutes 52 seconds East, 0.44 feet, and an axle found bears South 84 degrees 42 minutes 02 seconds East, 1.45 feet), passing an iron pin set at 38.42 feet;

Thence along the north lines of said Worstell lands the following four courses;

- 1.) North 84 degrees 42 minutes 10 seconds West, 135.00 feet to an iron pin set;
- 2.) North 76 degrees 46 minutes 51 seconds West, 125.10 feet to an axle found;
- 3.) North 73 degrees 58 minutes 21 seconds West, 55.14 feet to an axle found;
- 4.) South 66 degrees 04 minutes 45 seconds West, 115.67 feet to an iron pin set;

Thence through the lands of Robert H. Miller III, (OR 3004-805), North 25 degrees 50 minutes 25 seconds West, 515.37 feet to a point in the centerline of Macedonia Road, (Twp. Rd. 122, R\W 40'), passing an iron pin set at 491.23 feet;

Thence along the centerline of said road on a non-tangent curve to the right, with a delta angle of 21 degrees 03 minutes 34 seconds, a radius of 461.60 feet, an arc length of 169.67 feet, and a chord which bears North 56 degrees 20 minutes 18 seconds East, 168.71 feet to a point on the northwest corner of lands also presently owned by Robert H. Miller III, (OR 3004-805, Tract II);

Thence along the lines of said Miller lands the following three courses:

- 1.) South 15 degrees 25 minutes 38 seconds East, 166.95 feet to an iron pin set, passing an iron pin found at 22.80 feet;
- 2.) North 73 degrees 33 minutes 33 seconds East, 199.53 feet to an iron pin found;
- 3.) North 15 degrees 24 minutes 00 seconds West, 165.06 feet to a point in the centerline of said road, passing an iron pin found at 144.18 feet;

Thence along the centerline of said road the following four courses:

- 1.) North 76 degrees 40 minutes 26 seconds East, 45.27 feet to a point;
- 2.) Along a non-tangent curve to the left, with a delta angle of 15 degrees 35 minutes 18 seconds, a radius of 660.79 feet, an arc length of 179.78 feet, and a chord which bears North 67 degrees 40 minutes 26 seconds East, 179.23 feet to a point:
- 3.) Along a non-tangent curve to the left with a delta angle of 21 degrees 26 minutes 01 seconds, a radius of 431.33 feet, an arc length of 161.36 feet, an a chord which bears North 47 degrees 07 minutes 15 seconds East, 160.42 feet to a point;
