Thence, (by deed), along the east line of said McKenzie lands, South 02 degrees 46 minutes 39 seconds West, 1058.40 feet to a point in the centerline of Mt. Olive Road, (Twp. Rd. 122), passing an iron pipe found at 1038.39 feet;

Thence along the centerline of said road the following three courses:

1.) North 58 degrees 28 minutes 57 seconds West, 49.14 feet to a point;

3.) North 87 degrees 27 minutes 59 seconds West, 54.34 feet to a railroad spike found on the northeast corner of lands presently owned by Randall H. Peddicord, Trustee, (OR 2476-29);

Thence along the east line of said Peddicord lands South 04 degrees 19 minutes 10 seconds West, 165.68 feet to an iron pin found on the northeast corner of lands presently owned by Mt. Vernon Farms LTD.,(OR 2476-27), and the principal place of beginning;

Thence through the lands presently owned by said Mt. Vernon Farms, the following two courses:

1.) South 84 degrees 16 minutes 17 seconds West, 195.31 feet to an iron pin set;

2.) North 01 degrees 27 minutes 09 seconds West, 14.60 feet to an iron pin found, on the south west corner of said Peddicord lands;

Thence along the south line of said Peddicord lands, North 88 degrees 33 minutes 30 seconds East, 194.77 feet to an iron pin found, and the principal place of beginning, containing 0.03 acres more or less, and being part of Auditors Parcel Number 25-24-15-07-003.

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.
