

DESCRIPTION OF SURVEY FOR WILLIAM HILL TRUSTEE**JOB#2707 TRACT 7**

Situated in the State of Ohio, County of Muskingum, Township of Hopewell:

Being part of Military Lots 5, 6, and 10 of Quarter Township 3, Township 1, Range 9, of the US Military District, further **being part of** the William J Hill Trustee property, recorded in **Official Record Volume 2981, Page 921**, of said county's deed records, further **being part of** the Muskingum County **Auditor's Parcel Numbers 25-30-03-32-000, 25-30-03-35-000, and all of Parcel Number 25-30-03-33-000**, and more particularly described as follows;

Beginning at an iron pin (set) at the common corner for Military Lots 5, 6, 9, and 10 of said Quarter Township 3;

- #1- **THENCE North 03 degrees 09 minutes 54 seconds East 680.82 feet** along the common line for Military Lots 6 and 9 and common line for said Hill property and for the Brooks Kelly Schmidlin and Kira R Schmidlin property recorded in Official Record Volume 2521, Page 115 and the Robert Reaves property recorded in Official Record Volume 2502, Page 672 to an iron pin (found linn) at a corner of the Scott T Bare and Jennifer E Bare property recorded in Official Record Volume 2602, Page 887 and Official Record Volume 2988, Page 299, passing an iron pin (found) at 208.30 feet being a common corner for said Schmidlin and Reaves properties;
- #2- **THENCE South 87 degrees 22 minutes 29 seconds East 2618.25 feet** crossing Military Lot 6 and along a line of said Bare property to an iron pin (set) on the common line for said Military Lot 6 and Fractional Section 18 of said Hopewell Township and said Township and Range;
- #3- **THENCE South 03 degrees 03 minutes 57 seconds West 691.16 feet** along said Lot and Section line and common line for said Hill property and for the Matthew Ryan Stark and Michelle Stark property recorded in Official Record Volume 2955, Page 565 to an iron pin (set) at a common corner for said Military Lots 5 and 6;
- #4- **THENCE North 87 degrees 48 minutes 16 seconds West 1679.54 feet** into Military Lot 5 and through said Hill property to an iron pin (set);
- #5- **THENCE South 32 degrees 22 minutes 28 seconds West 150.73 feet** continuing through said property to an iron pin (set);
- #6- **THENCE South 45 degrees 46 minutes 06 seconds West 239.44 feet** continuing through said property to an iron pin (set);
- #7- **THENCE South 65 degrees 24 minutes 46 seconds West 349.91 feet** continuing through said property to an iron pin (set);
- #8- **THENCE North 31 degrees 51 minutes 34 seconds West 120.03 feet** continuing through said property to an iron pin (set);
- #9- **THENCE North 31 degrees 51 minutes 34 seconds West 244.55 feet** continuing through said property to an iron pin (set);
- #10- **THENCE South 61 degrees 35 minutes 49 seconds West 400.00 feet** continuing through said property and crossing into Military Lot 10 to an unmarked point in the centerline of Flint Ridge Road, passing an iron pin (set) at 370.00 feet;
- #11- **THENCE North 33 degrees 21 minutes 39 seconds West 94.23 feet** along said road and common line for said Hill property and for the Norman K See and Sharon L See property recorded in Official Record Volume 2538, Page 355 and the Timothy Shenk and Naomi Shenk property recorded In Official Record Volume 2556, Page 352 to an unmarked point;
- #12- **THENCE North 33 degrees 53 minutes 12 seconds West 107.79 feet** continuing along said road, Hill and Shenk properties to an unmarked point;
- #13- **THENCE North 26 degrees 24 minutes 13 seconds West 112.70 feet** continuing along said road and properties to an unmarked point;
- #14- **THENCE North 17 degrees 13 minutes 06 seconds West 118.98 feet** continuing along said road and properties to an unmarked point;
- #15- **THENCE North 14 degrees 27 minutes 11 seconds West 18.80 feet** continuing along said road and properties to an unmarked point on the common line for Military Lots 9 and 10;
