 752.71 feet, Chord Bearing North 08°42′23″ West, and a Chord Distance of 50.55 feet to a point
 on the west line of the subject parcel, the POINT OF BEGINNING of the parcel herein described;
- 2. (C2) a curve to the left having an Arc Length of 194.96 feet, Delta Angle 014°50′26″, Radius 752.71 feet, Chord Bearing North 18°03′02″ West, and a Chord Distance of 194.42 feet to a point;
- 3. (L1) North 25°28'15" West a distance of 187.60 feet to a point;
- 4. (L3) North 25°27'45" West a distance of 61.51 feet to a point;
- 5. (C3) a curve to the right having an Arc Length of 73.27 feet, Delta Angle 008°51′13″, Radius 474.13 feet, Chord Bearing North 21°02′08″ West, and a Chord Distance of 73.19 feet to the northwest corner of the subject parcel;

Thence coincident with the north line of the subject parcel and the south line of a parcel of land now or formerly conveyed to Gregory A & Susan R Burn, by a deed recorded in Official Record 2561, Page 888 of the records of the Muskingum County Recorder's Office, (L4) South 81°28′50″ East, a distance of 564.73 feet to a rebar set, passing a 5/8 rebar found capped "CR Harkness PS #6885" at a distance of 39.28 feet;
