Being part of the First Parcel of the prior deed reference Volume 882, Page 312, also being part of the Muskingum County Auditor's Parcel Number 25-25-35-20-05-000, and more particularly described as follows;

Commencing at the Northeast corner of the Northwest Quarter of said Section #20; thence along the East line of said Quarter S 03 22 26 W 1499.34 feet to an iron pin (set) at the place of beginning for the property herein intended to be described, passing iron pins (set) at 1024.04 feet, and 1253.04 feet; thence continuing along said East line S 03 22 26 W 247.52 feet to an iron pin (set); thence through said prior deed reference Volume 882, Page 312 N 86 37 34 W 728.61 feet to an iron pin (set); thence N 52 31 43 W 263.96 feet to the center line of Murrey Drive as delineated in Plat Book 16, Page 100, also passing an iron pin (set) on the East right-of-way line of said Murrey Drive at 235.49 feet; thence along the center line of said Murrey Drive N 08 51 32 E 100.00 feet; thence leaving said center line S 86 37 34 E 937.63 feet to the place of beginning, passing an iron pin (set) on the East right-of-way line of said Murrey Drive at 25.11 feet, containing 5.000 Acres.

The bearings within this description are based on reference pins (found) on Murrey Drive, as delineated in Plat Book 16, Page 100. Iron pins (set) are 5/8" rebar with aluminum identification caps. (C. R. Harkness R. S. 6885).




