Beginning at an existing nail (spike) in the center of County Road 28 (South Hopewell Road) at the southwest corner of the said northwest quarter; thence north 00 degrees 00 minutes 00 seconds east 197.62 feet along the west line of the said northwest quarter to a point in the center of said county road; thence leaving the said section line south 89 degrees 27 minutes 14 seconds east 319.80 feet to an iron pin set, passing an iron pin set at 25.00 feet; thence south 39 degrees 45 minutes 17 seconds east 78.65 feet to an iron pin set; thence south 26 degrees 58 minutes 37 seconds east 155.18 feet to an iron pin set on the south line of the said Northwest quarter of section 10; thence with the said South line north 89 degrees 27 minutes 14 seconds west 440.50 feet to the place of beginning.





