Thence along the centerline of South Hopewell Road, (Co. Rd. 28, R\W 40'), North 03 degrees 37 minutes 01 seconds East, 197.67 feet to a point on the northwest corner of said Berry lands, and the principal place of beginning;

Thence along the centerline of said road the following two courses:

- 2.) North 03 degrees 23 minutes 59 seconds East, 223.28 feet to a point;

Thence through the lands presently owned by Jeri D. Swingle, and Jeffrey K. Davis, (OR 2771-276), North 82 degrees 25 minutes 30 seconds East, 2639.39 feet to a point in the centerline of Gorsky Road, (Twp. Rd. 284, R\W 40'), passing an iron pins set at 22.11 feet, 1305.96 feet, 2627.59 feet;

Thence along the centerline of said road the following six courses:

- 2.) South 07 degrees 08 minutes 34 seconds West, 200.62 feet to a point;

- 4.) South 00 degrees 03 minutes 59 seconds East, 141.86 feet to a point;
- 5.) South 06 degrees 34 minutes 01 seconds West, 270.58 feet to a point;
- 6.) South 04 degrees 03 minutes 05 seconds West, 109.55 feet to a point on the northeast corner of lands presently owned by Rose L. Dinges, (OR 2853-734);
