THENCE, CONTINUING SOUTH 01 DEGREES - 09 MINUTES - 47 SECONDS EAST, 875.05 FEET TO A POINT IN COOPERMILL ROAD, PASSING AN IRON PIN FOUND AT 857.15 FEET;




