Being situated in the State of Ohio, County of Muskingum, Township of Hopewell, and being a part of the Northwest Quarter of Section 11, Township 18, Range 15, United States Military Lands, and being part of a 4.50 acre tract conveyed to Earl L. Westcott shown of record in Deed Book 303, page 482, Recorder's Office Muskingum County, Ohio, and being more particularly described as follows:

Beginning at an iron pin at the southeast corner of the Northwest Quarter of Section 11, and the southeasterly corner of said 4.50 acre tract; thence North 89 degrees 56 minutes West, along the south line of the Northwest Quarter of Section 11, and along the southerly line of said 4.50 acre tract, a distance of 204.34 feet to an iron pin on the centerline of Township Road No. 283 (50 feet wide); thence North 68 degrees 08 minutes 43 seconds West, along the centerline of said Township Road No. 283, and across said 4.50 acre tract, a distance of 455.53 feet to an iron pin at an angle point on the northerly line of said 4.50 acre tract; thence North 73 degrees 07 minutes 37 seconds West, across said 4.50 acre tract a distance of 214.85 feet to an iron pin; thence North 64 degrees 54 minutes 48 seconds West, across said 4.50 acre tract, a distance of 95.32 feet to a point on the westerly line of said 4.50 acre tract; thence North 11 degrees 20 minutes 17 seconds East, along the westerly line of said 4.50 acre tract, a distance of 233.12 feet to an iron pin on the centerline of said Township Road at the northwesterly corner of said 4.50 acre tract; thence South 36 degrees 36 minutes 09 seconds East, along the centerline of said Township Road No. 283, and along the northeasterly line of said 4.50 acre tract, a distance of 412.75 feet to an iron pin, at angle point in the northerly line of said 4.50 acre tract; thence South 74 degrees 50 minutes 57 seconds East, along the northerly line of said 4.50 acre tract, a distance of 649.72 feet to the place of beginning, containing 1.251 acres, subject however to all highways and easements of record, and of records, easements and restrictions on the respective utility offices.


