Situated in the State of Ohio, County of Muskingum, Township of Hopewell, southeast quarter of Section 12 and northeast quarter of Section 13, Township 18, Range 15. Being a portion of the lands conveyed to Charles E. & Anita G. Wright in Official Record 1627 Page 247 (Auditor's parcel #25-95-12-16-00 & #25-95-13-02-000) and being further described as follows:

Beginning at a stone found protruding from the side of a small bank marking the northwest corner of the northeast quarter of Section 13.

Thence, with the east line of the lands conveyed to James & Wava Teters in Deed Volume 536 Page 101, N 00°15'06" E 137.87 feet to a point in the center of Coopermill Road (County Road #71). Passing over an iron pin set at 109.70 feet.

Thence, with the center of Coopermill Road the following two (2) courses and distances:

- 1) with a curve to the left, radius = 635.00 feet, arc length = 137.35 feet, & chord bearing N 86°32'08" E, 137.08 feet to a point.
- 2) with a curve to the left, radius = 2794.00 feet, arc length = 212.81 feet, & chord bearing N 79°24'57" E, 212.76 feet to a point.

Thence, with new lines the following two (2) courses and distances:

- 1) S 03°10'34" E 429.84 feet to an iron pin set, passing over an iron pin set at 29.77 feet.
- 2) N 88°44'18" W 371.51 feet to an iron pin set.

Thence, with the east line of said Teters' land, N 00°15'06" E 235.77 feet to the place of beginning.

The parcel as surveyed contains a total of 3.255 acres, more or less (1.250 acres in Section 12 and 2.005 acres in Section 13).

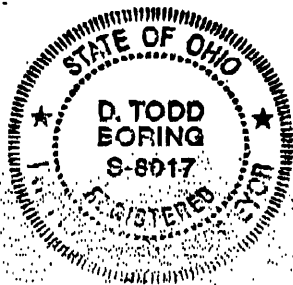
Subject to all legal easements, right-of-ways, setbacks, restrictions, & reservations of record.

Bearings are based on the north line of Section 13 as being N 90°00'00" W and are used to denote angles only.

All iron pins set are 5/8" x 30" long rebar with plastic caps labeled "Boring S-8017".

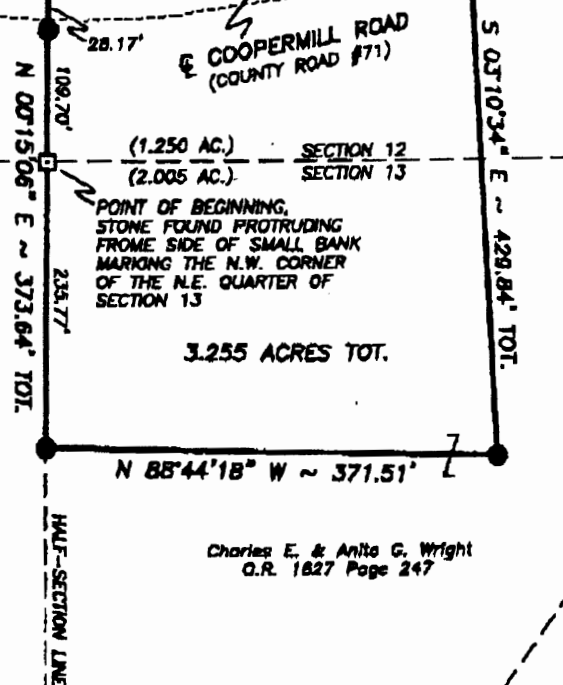

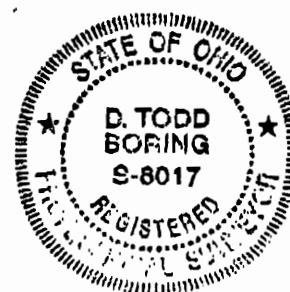
