Being a part of the west half of Section 13, Quarter Township 1, Township 18, Range 15 and being more particularly described as follows:

Commencing at the Northwest corner of Section 13, thence $50^{\circ}09'46''E$ for 1993.15 feet to the Southwest corner of Parcel Three as described on the previous deed recorded in Volume 808 Page 201 (passing through an iron pin at 369.60 feet) and the point of beginning;

Thence $50^{\circ}09'46''E$ along the West Line of Section 13 for 833.46 feet to an iron spike in County Road 126;
