Thence North 03°32'58" East, 666.54 feet to a point in Perryton road and passing an iron pin set at 627.06 feet.

Thence with said road South 53°22'11" East, 59.39 feet to a point.


Thence with said road South 56°46'22" East, 154.65 feet to a point.

Thence with said road South 62°16'40" East, 27.25 feet to the **PLACE OF BEGINNING** containing 3.1179 acres.




