

Survey Split of Danny R. and Bobbie L. Painter Lands in Jackson Township, Musk. Co.

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the Southwest Quarter of Section 7, and the Northwest Quarter of Section 14, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by Danny R. and Bobbie L. Painter, as per Deed Record 1064, Page 158, and being more particularly described as follows:

Beginning for reference at the southeast corner of the Southwest Quarter of Section 7, Township 3, Range 9, United States Military Lands;

Thence along the section line, (by deed), North 88 degrees 10 minutes 41 seconds West, 920.00 feet to a point;

Thence, (by deed), North 23 degrees 55 minutes 16 seconds West, 191.00 feet to a point in the centerline of O'Dell Road, (Twp. Rd. 93), and the principal place of beginning;

Thence along the south boundary lines of lands presently owned by Danny R. and Bobbie L. Painter (DR 1064-158), the following three courses:

1.) Along O'Dell Road, South 65 degrees 20 minutes 49 seconds West, 385.92 feet to a point in the centerline of said road;

2.) Along said centerline, South 72 degrees 43 minutes 11 seconds West, 284.88 feet to an iron pipe found;

3.) Along said centerline, South 72 degrees 34 minutes 04 seconds West, 95.11 feet to a point;

Thence through said Painter lands the following eleven courses:

1.) North 27 degrees 15 minutes 16 seconds West, 208.60 feet to an iron pin set, passing an iron pin set at 29.85 feet;

2.) North 27 degrees 15 minutes 42 seconds West, 203.47 feet to an iron pin set;

3.) North 05 degrees 13 minutes 31 seconds West, 78.40 feet to an iron pin set;

4.) North 19 degrees 36 minutes 55 seconds East, 178.37 feet to an iron pin set;

5.) North 73 degrees 56 minutes 46 seconds East, 182.00 feet to an iron pin set;

6.) North 61 degrees 08 minutes 13 seconds East, 191.76 feet to an iron pin set;

7.) South 71 degrees 31 minutes 22 seconds East, 83.75 feet to an iron pin set;

8.) North 51 degrees 34 minutes 33 seconds East, 168.21 feet to an iron pin set;

9.) South 60 degrees 01 minutes 39 seconds East, 169.91 feet to an iron pin set;

10.) South 18 degrees 23 minutes 08 seconds East, 224.47 feet to an iron pin set;

11.) South 66 degrees 43 minutes 40 seconds East, 293.95 feet to a point in O'Dell Road, (Twp. Rd. 93), passing an iron pin set at 273.55 feet;

Thence in the road and along the south line of Danny R. and Bobbie L. Painter lands, South 52 degrees 59 minutes 46 seconds West, 241.17 to the principal place of beginning, containing 11.99 acres more or less, and being part of Auditor's Parcel Numbers 29-10-07-14-003 +- 11.37 Acres, and 29-40-14-10-000 +- 0.62 Acres.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North as per GPS observations.

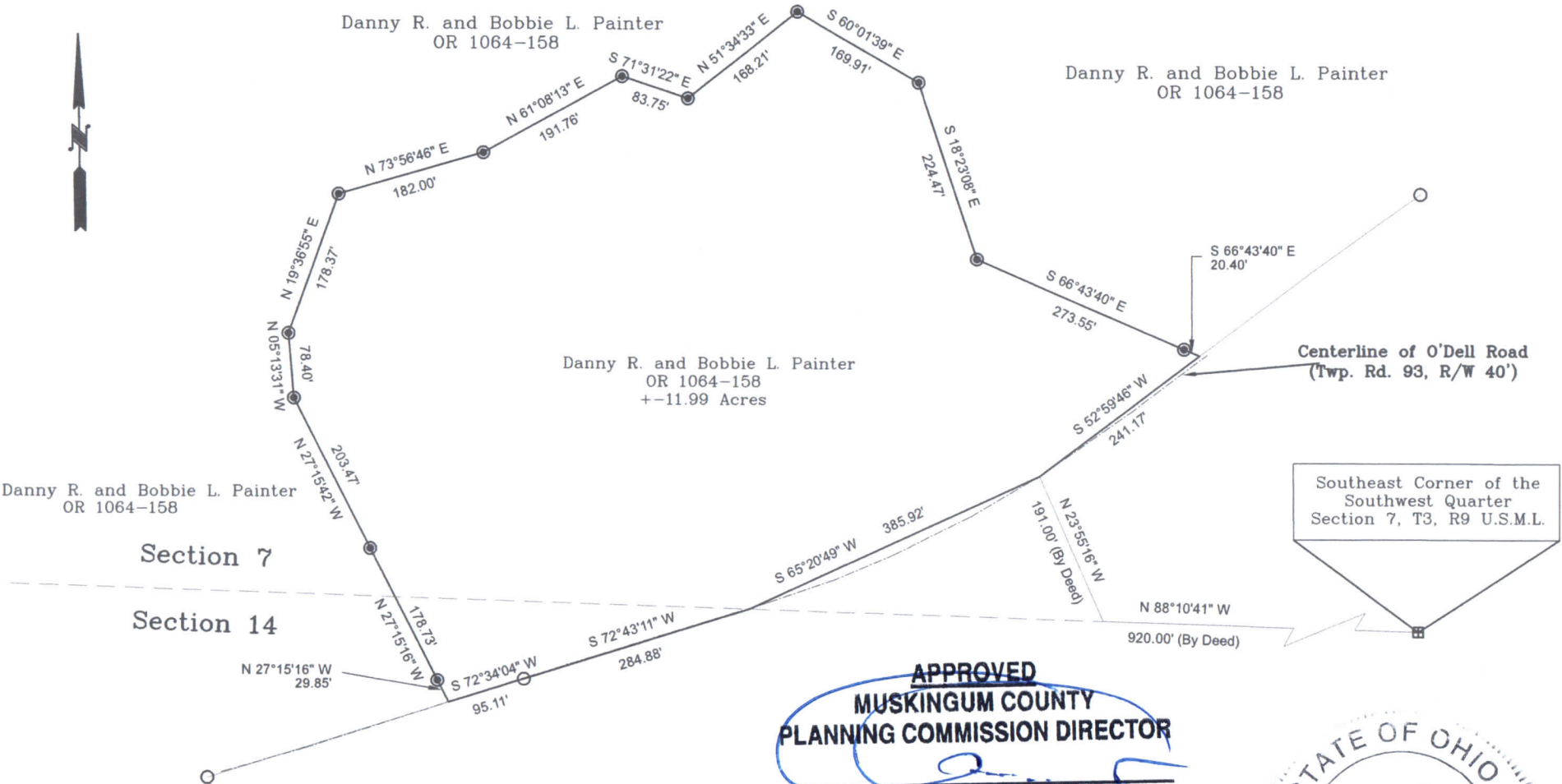
