North 06° 09' 39" East, 122.16 feet,

North 19° 59' 18" East, 133.35 feet,

North 33° 32' 07" East, 101.64 feet,

North 40° 10' 34" East, 258.24 feet,

to a point on the north line of said Lot 8, said point being also the intersection of centerlines of County Road 48 and County Road 314, said point being referenced by an iron pin South 86° 18' 50" West, 205.00 feet from said point of intersection,
