

Re-Survey of Robert and Linda Moran Lands in Jackson Township, Musk. Co.

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of Quarter Township 1, Lot 12, Township 3, Range 9, United States Military Lands, and being all the lands presently owned by Robert A. and Linda Sue Moran, Trustees, as per Official Record 3089, Page 18, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an iron pin found on the southeast corner of Lot 12, Quarter Township 1, Township 3, Range 9, United States Military Lands;

Thence along the north line of Lot 19, and the south line of Lot 12, and the north lines of lands presently owned by DNR LLC, (OR 2548-42), and Shon E. and Christine E. Bender, (OR 2834-928), North 88 degrees 02 minutes 14 seconds West, 1253.14 feet to an iron pin found on the southeast corner of lands presently owned by Stephen and Janell M. Nutbrown, (OR 2342-723), passing a point at 329.94 feet, from which an iron pin found is offline and perpendicular to the north 0.37 feet, and passing iron pins set at 453.76 feet, 788.05 feet, and 963.95 feet;

Thence along the east line of said Nutbrown lands, North 01 degrees 23 minutes 54 seconds East, 1000.88 feet to an iron pin found, on the southeast corner of Thomas L. and Sharon K. Tucker, (OR 1893-840), passing iron pins set at 367.42 feet, and 636.25 feet;

Thence along the lines of said Tucker lands, the following three courses:

- 1.) North 01 degrees 11 minutes 07 seconds East, 546.91 feet to an iron pin found;
- 2.) North 87 degrees 12 minutes 04 seconds West, 650.00 feet to an iron pin found, passing iron pins set at 258.61 feet, and 437.89 feet;
- 3.) North 44 degrees 38 minutes 19 seconds West, 623.20 feet to a point in the centerline of Mt. Zion Road, (Co. Rd. 313, R\W 40'), passing an iron pin set at 319.55 feet an iron pin found at 594.03 feet;

Thence along the centerline of said road, the following two courses:

- 1.) North 30 degrees 33 minutes 34 seconds East, 118.28 feet to a point;
- 2.) North 33 degrees 33 minutes 53 seconds East, 63.88 feet to an iron pin found on the southwest corner of lands presently owned by Elaine Slaughter, (DR 1160-421);

Thence along the south lines of said Slaughter lands the following three courses:

- 1.) South 79 degrees 38 minutes 41 seconds East, 1000.86 feet to a point in a 36 inch dia. Oak tree, passing iron pins set at 21.27 feet, 292.89 feet, 544.97 feet, and 806.94 feet;
- 2.) South 01 degrees 41 minutes 01 seconds West, 159.06 feet to an iron pin set, passing an iron pin set at 7.20 feet;
- 3.) South 87 degrees 56 minutes 39 seconds East, 722.36 feet to an iron pin found, on the northwest corner of lands presently owned by DNR LLC, (OR 2548-42), passing iron pins set at 284.30 feet, and 625.28 feet;

Thence along the west lines of said DNR lands, the following four courses:

- 1.) South 01 degrees 20 minutes 00 seconds East, 579.86 feet, passing an iron pin set at 265.69 feet;
- 2.) South 03 degrees 27 minutes 13 seconds East, 385.41 feet to an iron pin found, passing an iron pin set at 199.26 feet;
- 3.) South 88 degrees 09 minutes 51 seconds East, 511.75 feet to an iron pin found, passing an
