

## **DESCRIPTION**

**Situated in Jackson Township, Muskingum County, State of Ohio and being a part of Section 15, Second Quarter, Township 3 North, Range 9 West, United States Military Lands, also being the remaining part of the lands conveyed to Daniel L. and Nancy L. Brown by a deed recorded in Vol. 1136, Pg. 572, Muskingum County Recorder's Office, more fully described as follows:**

**Beginning at the Southwest corner of the Northeast Quarter of Section 15 and marked by a found iron pin;**

**thence N 89° 54' 37" W along the Southerly line of the Northwest Quarter of Section 15, a distance of 411.15 feet to the Southwest corner of subject title lands and marked by a found iron pin, passing a found iron pin at 329.24 feet;**

**thence N 0° 27' 07" W along the Westerly line of subject title lands, a distance of 884.56 feet to a point on the curved center line of O'Dell Road, passing set iron pin at 854.56 feet;**

**thence the following 4 courses along the center line of O'Dell Road;**

**thence Northeasterly and to the left along the curved center line to the Point of Tangency, Curve Data being, Delta = 25° 02' 24", Radius = 392.64 feet, Chord = N 82° 24' 29" E 170.23 feet;**

- 1. N 69° 53' 17" E 108.13 feet to a point;**
- 2. N 66° 58' 57" E 502.42 feet to a point;**
- 4. N 65° 58' 13" E 463.85 feet to a point marking the Northwest corner of the lands of Michael A. Barker (1926/596);**

thence S 0° 32' 10" E 1331.42 feet along the line common to the lands of Michael A. Barker and subject title lands to a point marked by a found iron pin, passing a set iron pin at 30.00 feet and a found iron pin at 761.42 feet;

thence N 89° 54' 37" W 750.68 feet along the Southerly line of subject title lands to the Point of Beginning.

Bearings are based on the North-South half section line being N 0° 27' 06" W.

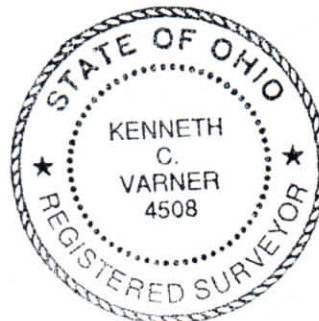
