

DESCRIPTION OF A 4.697 ACRE TRACT

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being a part of the Southwest Quarter of Section 15, Township 3, Range 9, United States Military Lands, and being a part of that original 30.214 acre tract (being a part of Parcel Number 29-30-15-21-000) as conveyed to Mildred M. Willey, Trustee of the Mildred M. Willey Amended and Restated Trust, Dated May 12, 2006 in Deed Volume 2041, Page 367, all references being to those of record in the Recorder's Office, Muskingum County, Ohio, said 4.697 acre tract being more particularly bounded and described as follows:

Commencing at a railroad spike found in the centerline of Township Road 316, also known as Cannon Road, where said centerline intersects the south line of said Section 15, said railroad spike being a southwesterly corner of that 10.707 acre tract as conveyed to John B. Singleton by Deed Volume 2280, Page 506;

Thence leaving said Section line and along the centerline of Cannon Road the following two (2) courses and distances:

North 09°29'20" West, 174.20 feet to a point; and . . .

North 27°17'20" West, 27.87 feet to a point at a northwesterly corner of said 10.707 acre tract, said point being the **Point of Beginning** of the tract herein described;

Thence continuing along said centerline of Cannon Road, **North 27°17'20" West, 514.68 feet** to a point at a southwesterly corner of that 17.069 acre tract as conveyed to Timothy J. Singleton, II and Nancy J. Singleton by Official Record 2497, Page 542;

Thence leaving said centerline of Cannon Road along the southerly lines of said 17.069 acre tract the following two (2) courses and distances:

North 64°42'39" East, passing a 5/8" iron pin found at 30.02 feet, a total distance of 250.00 feet to an 5/8" iron pin found; and . . .

North 82°18'24" East, 213.47 feet to an 5/8" iron pin set;

Thence with a new division line across said Willey tract, **South 50°57'12" East, 197.83 feet** to an 5/8" iron pin set on a northerly line of said 10.707 acre tract;

Thence along the northerly lines of said 10.707 acre tract the following two (2) courses and distances:

South 24°17'07" West, 340.98 feet to an 5/8" iron pin found; and

South 53°48'17" West, passing an 5/8" iron pin found at 236.07 feet, a total distance of **266.44 feet** to the **Point of Beginning** and containing 4.697 acres more or less, according to a survey by Jobs Henderson and Associates Inc. in November of 2016.

The above described parcel being a part of Muskingum County, Ohio Auditor's Parcel Number 29-30-15-21-000.

The bearings in the above description are based on bearings taken from the description of said 10.707acre tract as conveyed to John B. Singleton as recorded in Deed Volume 2280, Page 506.

All iron pins set are 5/8" in diameter rebar by 30" in length with red identification caps marked "J&H, PS 8283".

Subject to all valid and existing easements, restrictions and conditions of record.
