Situated in the Township of Jackson, County of Muskingum and the State of Ohio.

Being located in the School Lot No.25 in Quarter Township No.1, Township 3, Range 9 of the United States Military District and being all of a 2.5 acre tract as conveyed to Duane O. and Lanita L. Hood by a Warranty Deed-Survivorship as recorded in Volume 1130 at Page 117 (Parcel No.29-29-40-01-09-000) of the Muskingum County Deed Records and being more fully described as follows:-

COMMENCING at a point at the southeast corner of the Southwest Quarter of Section 13, Township 3, Range 9;

THENCE with the east line of said Southwest Quarter, North 738.00 feet (Deed) to a stone monument (found) at the northeast corner of a 43.00 acre tract as conveyed to W. Graham (Volume 541, Page 181) and at the southeast corner of a 60.48 acre tract as conveyed to Duane O. and Lanita L. Hood (Volume 1130, Page 117);

THENCE with the east line of the Southwest Quarter, North 0 deg. 15 min. 44 sec. West, 405.38 feet to an iron pin (found);

THENCE continuing with the east line of said Southwest Quarter, North 0 deg. 10 min. 10 sec. East, 731.60 feet to an iron pipe (found) at the southwest corner of school Lot 25;

THENCE with the west line of School Lot 25 and the east line of said Southwest Quarter, North 0 deg. 10 min. 10 sec. East, 798.65 feet to a point in the center of Muskingum County Road 38 and being the place of beginning of the tract herein to be described;

THENCE from said beginning with the west line of said School Lot 25, North 0 deg. 10 min. 10 sec. East, 280.08 feet to an iron pin (set);

THENCE continuing, North 0 deg. 10 min. 10 sec. East, 60.00 feet to a point in Wakitomika Creek and at the southwest corner of a 94.585 acre tract as conveyed to T. Everett (Volume 1078, Page 611);

THENCE with the southerly line of said 94.585 acre tract and in Wakitomika Creek the following three (3) courses; South 54 deg. 40 min. 24 sec. East, 55.59 feet to a point;

THENCE South 59 deg. 54 min. 15 sec. East, 414.23 feet to a point;

THENCE South 48 deg. 34 min. 16 sec. East, 108.73 feet to a point to the intersection of Wakitomiko Creek and a small run;

THENCE South 41 deg. 25 min. 44 sec. west, 18.67 feet to a point at the northeast corner of a 17.84 acre tract as conveyed to K. Young (Volume 962, Page 260);

THENCE South 81 deg. 16 min. 00 sec. West, 358.98 feet to an iron pin (set) in the centerline of County Road No.38 and at the northwest corner of said 17.84 acre tract;


