

Description 82.522 acre parcel

Being a part of the northwest quarter of section 14 and part of the northeast and southeast quarters of section 15, Jackson Township, T-3 N, R-9 W, U.S. Military District, Muskingum County, Ohio, also known as all of the lands conveyed unto Elvin L. and Janice A. Pitcher in Vol. 1543 page 680, #29-30-15-03-000, #29-30-15-05-000, #29-30-15-23-000 and #29-40-14-11-000.

Described as follows:

Beginning at a 5/8 inch rebar found marking the northeast corner of the southeast quarter of section 15 the TRUE POINT OF BEGINNING.

thence with the following TEN (10) COURSES:

- 1) S 00 degrees 32' 51" W 1318.67 feet along the section line to a 5/8 inch rebar found;
- 2) N 89 degrees 39' 11" W 1363.75 feet along Jill F. Standeford, Helene A. Randall (Life Est.)'s (Vol. 1578 page 646) north line to a 1 inch I.D. pipe found;
- 3) N 00 degrees 40' 25" E 1320.26 feet along Denise K. Walters, Trustee's (Vol. 1796 page 16) east line to a 5/8 inch rebar found on the quarter section line;
- 4) N 00 degrees 17' 03" E 1318.10 feet (passing into the northeast quarter of section 15) along Michael A. Barker's (Vol. 1926 page 596) east line to an iron pin set;
- 5) S 89 degrees 36' 32" E 1358.52 feet along Vernon E. and Neola L. Heimberger, Trustees' (Vol. 1633 page 278) south line to a 5/8 inch rebar found on the section line;
- 6) N 00 degrees 11' 01" E 315.42 feet along the section line to a point, witnessed by a 5/8 inch rebar found S 00 degrees 11' 01" W 13.83 feet;
- 7) S 89 degrees 22' 01" E 14.00 feet (passing into section 14) along said Heimberger's south line and along Dove Road (T.R. 318 A) to a point, witnessed by a 5/8 inch rebar found S 00 degrees 11' 01" W 13.56 feet;
- 8) S 00 degrees 11' 01" W 329.36 feet along Richard E. Heimberger's (Vol. 1992 page 858) west line to a 5/8 inch rebar found;
- 9) N 89 degrees 36' 32" W 14.00 feet along said Richard E. Heimberger's west line to a 5/8 inch rebar found on the section line;
- 10) S 00 degrees 11' 01" W 1304.64 feet along the section line to the TRUE POINT OF BEGINNING.

This parcel contains 82.522 acres, but subject to all highways and easements of record. Containing 41.151 acres in the northeast quarter of section 15, 41.265 acres in the southeast quarter of section 15 and 0.106 acres in the northwest quarter of section 14.

All iron pins set are 5/8 inch rebars with a plastic I.D. cap marked "Baker 6938".

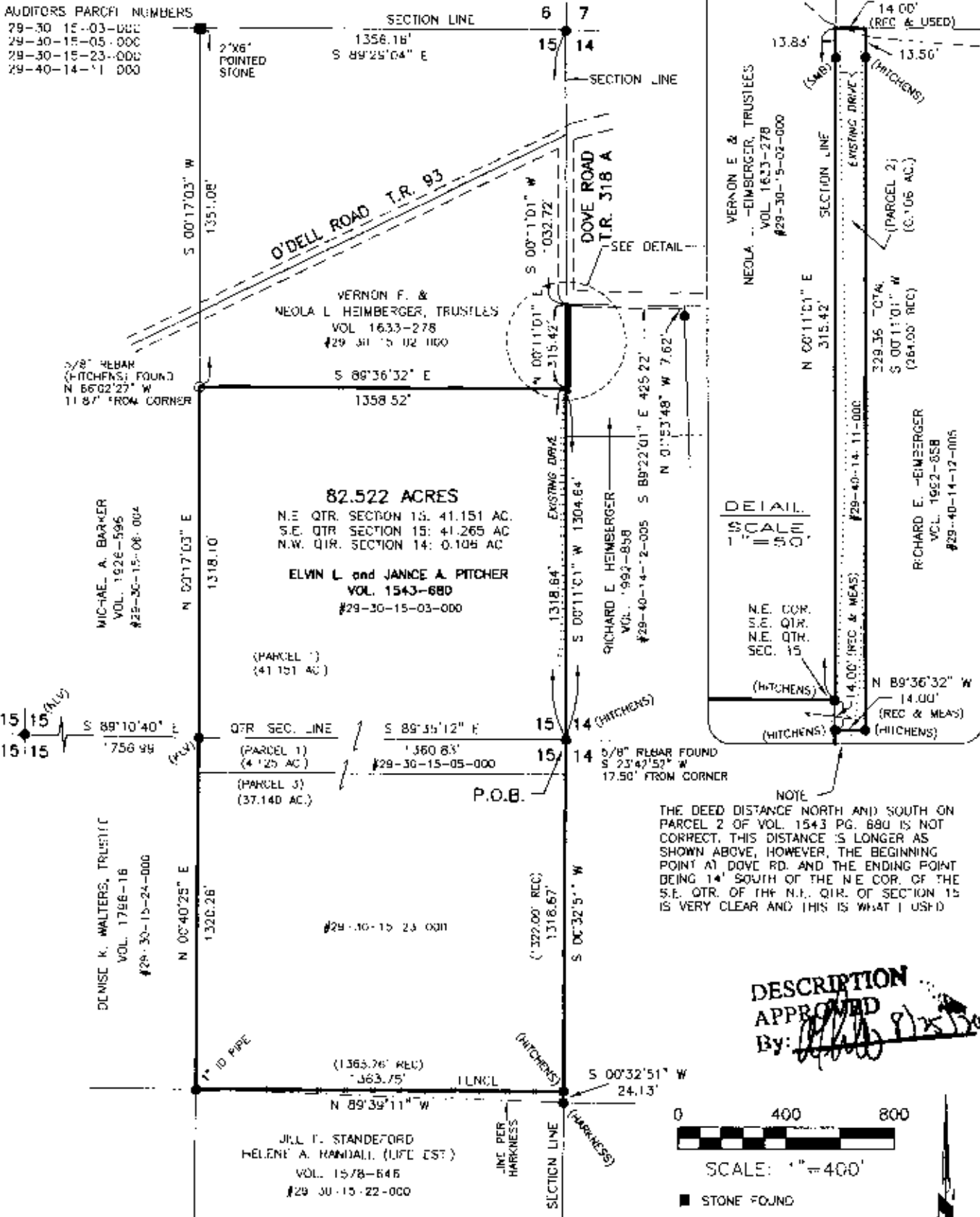
