

Re-Survey of part of Rolland B. and Alice B. Untied Lands, Jackson Township

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the Southeast Quarter of Section 17, Township 3, Range 9, United States Military Lands, and being all the lands presently owned by Rolland B. and Alice B. Untied, as per Deed Record 562, Page 404, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an iron pin found at the southeast corner of the Northeast Quarter of Section 17;

Thence along the east line of Section 17, and the west line of lands presently owned by John H. and Darlene M. O Flarety(DR 1122-213), South 01 degrees 28 minutes 33 seconds West, 177.65 feet to a an iron pipe found on a north line of lands presently owned by the State of Ohio,(OR 1502-769);

Thence along the lines of said State lands, the following three courses

- 1.) North 85 degrees 15 minutes 44 seconds West, 40.50 feet to an iron pipe found;
- 2.) North 73 degrees 19 minutes 24 seconds West, 175.40 feet to an iron pipe found;
- 3.) North 02 degrees 12 minutes 42 seconds West, 126.89 feet to a point on the north line of the Southeast Quarter of Section 17, passing an iron pin found at 117.00 feet;

Thence along the north line of said Southeast Quarter, South 89 degrees 14 minutes 25 seconds East, 217.88 feet to the principal place of beginning, containing 0.76 acres, more or less.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per GPS observations.


