

## Re-Survey of Betty L. Coulter Lands

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the Northwest Quarter of Section 18, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by Betty L. Coulter as per Deed Record 1045, Page 122, and being more particularly described as follows:

Beginning for reference at the southeast corner of the Northwest Quarter of Section 18, Township 3, Range 9, United States Military Lands;

Thence along the south line of said quarter section, (by deed) North 88 degrees 15 minutes 04 seconds West, 982.11 feet to a point on the southeast corner of lands presently owned by Michael B. Martin,(OR 2081-469);

Thence along the east line of said Martin lands, (by deed), North 01 degrees 29 minutes 04 seconds East 142.33 feet to a point on the centerline of Raider's Road,(Co. Rd. 616), and being the principal place of beginning;

Thence along said centerline, South 71 degrees 42 minutes 31 seconds West, 184.69 feet to a point on the southeast corner of lands presently owned by Jon D. and Victoria Roberts,(DR 1050-257);

Thence along the lines of said Roberts lands the following two courses:

- 1.) North 25 degrees 50 minutes 21 seconds West, 415.42 feet to an iron pin found, passing iron pins found at 38.70 feet, and 128.50 feet;
- 2.) South 66 degrees 33 minutes 38 seconds West, 49.79 feet to an iron pin found on the east line of lands presently owned by Michael B. Martin(OR 2081-469);

Thence along the lines of said Martin lands the following two courses:

- 1.) North 15 degrees 55 minutes 34 seconds West, 390.07 feet to an iron pin found;
- 2.) South 88 degrees 42 minutes 05 seconds East, 526.35 feet to an iron pin found on the west line of lands presently owned by Carol L. Barcus, (DR 1106-622), passing an iron pin found at 267.92 feet;

Thence along the west line of said Barcus lands, South 01 degrees 29 minutes 04 seconds West 29.61 feet to an iron pin found on the northwest corner of lands presently owned by WBS Rental Properties Limited,(OR 2563-745);

Thence along the west line of said WBS rental lands, South 01 degrees 29 minutes 04 seconds West, (passing an iron pin found at 593.78 feet), 629.89 feet to the principal place of beginning, containing 5.98 acres, more or less;

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per GPS observations.
