SURVEY DESCRIPTION
FOR
ROY ADAMS

Situated in the Southeast quarter of Section #18, T-3-N, R-9-W, U.S.M.L. Jackson Township, Muskingum County, Ohio. Being part of the lands of Roy Adams as conveyed in Deed book 1024, page 547 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at an iron pin found in the Northwest corner of the East half of the Southeast quarter of Section #18; thence, S.04 30°00"W. a distance of 850.48 feet along the West line of J. McKee (491/465) to a set iron pin, BEING THE POINT OF BEGINNING; thence, S.87 53°53"E a distance of 104.00 feet along the South line of said McKee lands to a set iron pin; thence, S.03 53°30"W. a distance of 383.87 feet through the lands of R. Adams (1024/547) to a set iron pin; thence, N.87 29°00"W. a distance of 108.05 feet to a set iron pin on the East line of S. Martin, et al (546/70); thence, N.04 30°00"E. a distance of 383.24 feet along the East lines of said Martin lands and the Jackson Township (825/11) to the POINT OF BEGINNING, passing found iron pins at 22.78 and 299.52'.

The above described parcel contains 0.933 acres, more or less, and is subject to all legal easements and right of ways. North is based upon record bearings in Deed Book 825 page 11. All set iron pins are 3/4" x 30" iron pipes with I.D. Caps.

Reserving across the South end of the above described parcel, a twenty (20.00') foot wide Right of Way described as follows:

Beginning at a set iron pin on the Southwest corner of the above described parcel; thence, N.04 30°00"E. a distance of 20.01 feet along the East line of S. Martin, et al (546/70) to a point; thence, S.87 29°00"E. a distance of 107.84 feet through the above described parcel to a point; thence, S.03 53°30"W. a distance of 20.01 feet along the East line of the above described parcel to a set iron pin, being the Southeast corner of said parcel; thence, N.87 29°00"W. a distance of 108.05 feet along the South line of said parcel to the POINT OF BEGINNING.

The above described Right of Way covers 2,158.88 square feet.




