Re-Survey of Gail J. and D. Marie Arnold Lands in Cass and Jackson Twp., Muskingum County

Tract Three

Situated in the State of Ohio, County of Muskingum, Township of Cass, and being part of the Northwest Quarter of Section 15, and part of Military Lot 5, Township 3, Range 8, and Township of Jackson, part of Quarter Township 1, part of Lot 21, Township 3, Range 9, United States Military Lands, and being part of the lands presently owned by Gail J. and D. Marie Arnold as per Official Record 1982, Page 544, ( First and Ninth Parcels), and Deed Record 1072, Page 135, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at a wooden fence post on the Southwest Corner of the Northwest Quarter of Section 15, Township 3, Range 8, United States Military Lands;

Thence along the Jackson\Cass Township Line, North 01 degrees 56 minutes 56 seconds East, 259.81 feet to an iron pin set, on the west line of Cass Township Cemetery, passing an iron pin set at 1.00 feet;

Thence along the cemetery lines the following three courses:

- 1.) South 34 degrees 18 minutes 14 seconds East, 18.29 feet to an iron pin set;
- 2.) North 70 degrees 01 minutes 32 seconds East, 90.81 feet to an iron pin set;
- 3.) North 21 degrees 35 minutes 56 seconds West, 309.66 feet to an iron pin set on the south right of way of Raiders Road, (Co. Rd. 616), passing an iron pin set on the township line at 237.95 feet;

Thence across the road, North 14 degrees 08 minutes 36 seconds West, 19.86 feet to the property line on the south line of the lands presently owned by the State of Ohio, (formerly Canal Lands);

Thence along State of Ohio lands, North 74 degrees 47 minutes 22 second East, 425.17 feet to a point;

Thence through the lands presently owned by Gail J. and D. Marie Arnold , (OR 1982-544), the following three courses:

- 1.) South 31 degrees 10 minutes 16 seconds East, 278.30 feet to an iron pin set, passing an iron pin set at 20.44 feet on the right of way of said Raiders Road;
- 2.) North 76 degrees 38 minutes 44 seconds East, 392.69 feet to an iron pin set;
- 3.) North 15 degrees 58 minutes 05 seconds West, 280.32 feet to a point on the south line of the State of Ohio lands, passing an iron pin set on the right of way of said Raiders Road, at 260.88 feet;

Thence along the south line of said State of Ohio lands, North 74 degrees 47 minutes 22 seconds East, 892.92 feet to a point on the northwest corner of lands presently owned by Nicholas G. Rine, (OR 2412-356);

Thence along the lines of said Rine lands the following four courses:

- 1.) South 13 degrees 15 minutes 25 seconds East, 553.79 feet to an iron pin found, passing an iron pin found at 19.56 feet;
- 2.) South 56 degrees 17 minutes 41 seconds East, 122.70 feet to an iron pin found;
- 3.) North 59 degrees 34 minutes 34 seconds East, 107.34 feet to an iron pin found;
