

Re-Survey of Sherryl L. Harlan and Rose A. Barnhart Lands
in Jackson Township, Muskingum County.

Situated in the State of Ohio, County of Muskingum, Township of Jackson, Quarter Township 1, and being part of Lots 25, and 24, Township 3, Range 9, United States Military Lands, and being all the lands presently owned by Sherryl L. Harlan, and Rose A. Barnhart, as per Official Records 3192, Page 193, and 3192, Page 1, and being more particularly described as follows:

Beginning for reference at an iron pin found at the southeast corner of Lot 25, Township 3, Range 9, United States Military Lands;

Thence along the lot line, North 02 degrees 38 minutes 42 seconds East, 15.00 feet to a point in the centerline of Alpine Highway, (Twp. Rd. 315), and the principal place of beginning;

Thence along the centerline of said road the following four courses:

- 1.) South 77 degrees 08 minutes 59 seconds West, 26.91 feet to a point;
- 2.) South 85 degrees 54 minutes 28 seconds West, 61.80 feet to a point;
- 3.) North 88 degrees 31 minutes 09 seconds West, 58.82 feet to a point;
- 4.) North 86 degrees 55 minutes 43 seconds West, 117.78 feet to a point on the southeast corner of lands presently owned by Gerald D. Bowman, (OR 2881-488, and OR 2977-591);

Thence along the east lines of said Bowman lands the following four courses:

- 1.) North 00 degrees 18 minutes 01 seconds East, 718.14 feet to an iron pin found, passing an iron pin found at 18.18 feet;
- 2.) North 36 degrees 13 minutes 41 seconds West, 175.84 feet to an iron pin found;
- 3.) North 13 degrees 54 minutes 04 seconds West, 108.34 feet to an iron pin found;
- 4.) North 09 degrees 50 minutes 07 seconds West, 406.91 feet to an iron pin found on the south line of lands presently owned by James R. Priest, (OR 2249-768);

Thence along the south line of said Priest lands, South 87 degrees 03 minutes 38 seconds East, 531.26 feet to a point in the centerline of West Carlisle Road, passing an iron pin found at 497.87 feet, and the lot line at 522.41 feet;

Thence along the centerline of said road, the following twelve courses:

- 1.) South 09 degrees 19 minutes 56 seconds East, 56.82 feet to a point;
- 2.) South 10 degrees 42 minutes 30 seconds East, 146.98 feet to a point;
- 3.) South 14 degrees 20 minutes 56 seconds East, 115.61 feet to a point;
- 4.) South 17 degrees 13 minutes 56 seconds East, 124.29 feet to a point;
- 5.) South 20 degrees 15 minutes 22 seconds East, 140.20 feet to a point;
- 6.) South 21 degrees 38 minutes 33 seconds East, 31.50 feet to a point;
- 7.) South 23 degrees 22 minutes 06 seconds East, 49.79 feet to a point;
- 8.) South 26 degrees 42 minutes 10 seconds East, 49.57 feet to a point;
- 9.) South 32 degrees 09 minutes 48 seconds East, 52.95 feet to a point;
- 10.) South 36 degrees 48 minutes 29 seconds East, 50.31 feet to a point;
- 11.) South 41 degrees 45 minutes 03 seconds East, 53.41 feet to a point;
- 12.) South 46 degrees 24 minutes 59 seconds East, 100.26 feet to a point on the northwest corner of lands presently owned by the Sensibaugh Bros. LLC, (OR 3065-73);

Thence along the west line of said Sensibaugh lands, South 32 degrees 52 minutes 33 seconds
